# AGRI 5360 Contemporary Issues in Agricultural Business (3 credit hours) Fall 2017: Legal Issues of Innovative Agribusinesses

**COURSE DESCRIPTION**: AGRI 5360 is a topical course designed to study key areas relating to agribusiness management. This semester, we will study the legal issues surrounding starting and operating small, innovative agribusinesses. These include such topics as types of business structure, legal issues in both starting and ending businesses, general legal issues of contracts and torts, ag-related legal issues such as land and fencing laws, owner responsibilities and liability, and various food establishment laws. It is not a course designed to give any form of legal advice, and the material taught should not be interpreted as such.

**COURSE OBJECTIVES:** By design, this course aims to provide a practical and straightforward approach to starting, planning, and implementing basic business strategies, and legally preparing owners and businesses for the legal realities of doing business, particularly in Texas. We will cover a wide range of business legal topics with a goal of being able to use and understand those principles as they apply to practical situations. By the end of this semester, this course will provide you with the following outcomes:

- Learn major business structures, with their pros and cons.
- Gain the ability to apply critical thinking skills.
- Understand different business laws and how they apply to innovative agribusinesses.
- Learn legal principles important for starting a small business.
- Gain knowledge of contracts and the laws that govern them.
- Understand how torts can affect a business.

Weekly online modules will be used to teach the core aspects of the course using:

- Guided online discussion boards
- Topical readings form online and posted documents
- Writing and reflection assignments

#### **COURSE TEXTBOOKS:**

None required. Readings will be assigned from freely available Internet sources.

**COURSE MATERIALS:** Course documents, announcements and links to other materials will be posted on Blackboard accessed at <a href="http://blackboard.shsu.edu">http://blackboard.shsu.edu</a>.
