Since it is an online course, most of the time you will be interacting with me over phone, fax, email, blackboard etc.; however when you are on-campus you can always visit me during my office hours.

Course Description: This is an introductory undergraduate-level course designed to expose students to elementary and basic concepts in microeconomics as well as macroeconomics. The first half of the semester will discuss topics related to microeconomics such as, demand & supply, cost of production and different forms of markets (competitive and monopoly). The second half of the semester will be devoted to macroeconomics aspects of the economy such as GDP & Growth, consumer price index, inflation, monetary system, aggregate demand & supply. Graphs and simple algebra will be used to simplify the comprehension of the concepts central to economic theory.

Learning Outcomes: By the end of this course, students should be able to learn:

- 1. Develop an understanding of fundamental principles, generalizations, and theories in economics
- 2. Gain some factual knowledge about the US economy
- 3. Learn how to apply course materials to critically evaluate economic issues.

IDEA Course Evaluation Learning Objectives:

Tutoring

Evaluation

Each student will be evaluated on the basis of his or her performance in the exams and weekly quizzes.

1. **Exams (80%):** There will be four mid-term exams and one comprehensive final exam. However, you may miss one of the exams as the best FOUR out of the FIVE exams will be considered for the final course grade. Each exam will be worth 20% of the final grade. Each mid-term exam will be on-line and will have 40 multiple-choice questions. Final exam will have 50 questions.

Each exam will be timed and will be available for ONE week and students will have 2 hours to complete it. For example, if you open the exam at 11am, then you are supposed to complete it by 1pm as you have only 2 hours to complete it. All exams will be due on 11.59pm (not 11.59am) on the last day of its availability.

Without exception, no additional time will be given to complete the exam, and under no circumstances will the exam deadline will be extended. To avoid last minute personal/family emergencies or technical glitches, students are advised to take the exams atleast 2 days before the deadline. If you wait till the last day to take the exam, then you risk an unforeseen event forcing you to take a zero in that exam. In case you miss an exam due to unforeseen circumstances, then the missed exam will be replaced by 40% weightage of the final exam.

2. Quizzes (20%): There will be 10 quizzes. Each quiz will consist of 20 multiple choice questions. The best 5 quizzes (out of 10) will count for 20% of the final grade. Quizzes will open on Wednesday at 11:59pm and will be due on Sunday midnight.

Exams are closed book and cheating or use of unfair means will result into an F.
