

## Introduction to Economics Econ 2300-06

**Course Description:** This introductory course in economics is designed to provide students with an understanding of the basic principles of both microeconomics and macroeconomics. The first part of the course focuses on microeconomics that includes individual decision making and market mechanism. It explains how households, businesses, workers, employers, and government make decision when there are limited resources and unlimited wants. With this goal, we will discuss basic ideas of tradeoffs, opportunity cost, forces of supply and demand, the price system, efficiency, firm behavior, and different market structures. The second part of the course focuses on macroeconomics that provides students with an understanding of the economy as a whole. It explains how economic events affect many households, firms, and markets simultaneously. With this goal, we will discuss models to measure and analyze the main issues of an economy like gross domestic product (GDP), general price level and inflation, unemployment, growth, and business cycles. The knowledge and skills you acquire in this course will enable you to think like an economist and also be needed in some of the courses you will take in the future. Credits: 3

**Teaching Approach:** The instruction will consist of lectures, power point slides, class discussions, and homework problems. Homework questions will be assigned in lectures but will not be collected. However, you are expected to solve all homework questions; your learning and success in the course critically depends on regular study and solving the homework question sets. **The homework assignments are meant to prepare you for the tests.** All students must regularly check **Blackboard** (<u>https://blackboard.shsu.edu/webapps/login/</u>) for course materials and points obtained for quizzes and exams.

**Exams and Grading:** There will be 5 quizzes (25 points each), 4 midterm exams (100 points each), and a final exam (100 points). Dates of the exams will be announced in lecture. Exams and quizzes will consist of multiple choice questions. Topics covered in midterms will be announced in class. However, the final exam will be **comprehensive**. They will count toward the course grade as follows.

• Study the subject covered in class as soon as possible using the text and/or your notes. Solve the homework problems. The purpose of homework problems is to enhance students' understanding of the
