**Course Description:** This introductory course in microeconomics is designed to provide students with an understanding of the basic economic principles including individual decision making and market mechanism. It explains how households, businesses, workers, employers, and government make decision when there are limited resources and unlimited wants. With this goal, the course discusses basic ideas of tradeoffs, opportunity cost, forces of supply and demand, the price system, efficiency, firm behavior, and different market structures. The knowledge and skills you acquire in this course will enable you to think like an economist and also be needed in some of the courses you will take in the future. Credits: 3

1. Learn the fundamental microeconomic terminology, concepts, and theories.
2. Gain factual knowledge about individual behavior, firm behavior, and markets.
3. Learn to apply economic principles to improve thinking, problem solving, and decision making.

**Teaching Approach:** The instruction will consist of lectures, power point slides, class discussions, and homework problems. Homework questions will be assigned in lectures but will not be collected. However, you are expected to solve all homework questions; your learning and success in the course critically depends on regular study and solving the homework question sets. **The homework assignments are meant to prepare you for the tests.** All students must regularly check **Blackboard**

**Exams and Grading:** There will be 5 quizzes (25 points each), 4 midterm exams (100 points each), and a final exam (100 points). Dates of the exams will be announced in lecture. Exams and quizzes will consist of multiple choice questions. Topics covered in midterms will be announced in class. However, the final exam will be **comprehensive**. They will count toward the course grade as follows.

The purpose of homework problems is to enhance students' understanding of the basic concepts and methodologies learnt in class.
