AGBU 3367 - Agricultural Finance

Advanced agribusiness management applications of borrowed capital to operations; methods of determining loan needs for farmers; budgeting incomes to facilitate repayment of loans; cost of using borrowed capital; management of financial resources in agribusiness; and time value of money applications. Prerequisite: AGBU 2389 with a grade of C or better. Credit 3.

Text: Foundations of Finance, by Keown, Martin, Petty, and Scott, 9th ed. This text is <u>required</u>. We may also use internet readings, handouts, and other material placed on Blackboard or on reserve in the library.

Calculator: A financial calculator is <u>required</u> for this course. Recommended models are TI 83 Plus or HP 10BII. Others are okay, as long as they have built-in financial functions. You must bring your financial calculator to class every time. Cell phones may not be used for calculators.

Course Objectives

AGBU 3367 is a course designed to introduce students to key financial principles that will enable a business owner or manager to properly evaluate the financial condition of a firm, and understand the changes that may be used to align the financial status with the firm's goals. Key concepts include statement analysis, interest rates, cost of capital, time value of money, capital budgeting, and working capital management. Specific objectives are:

- Gaining factual knowledge (terminology, classifications, methods, trends)
- Learning fundamental principles, generalizations, or theories
- Learning to apply course materials (to improve thinking, problems solving, and decisions)
- Developing specific skills, competencies, and points of view needed by professionals in the business financial management field

Evaluation of Learning Outcomes

Note that homework problem sets will generally be taken up for a completion-type grade, but only a few will be fully graded. They are for your learning, and you should diligently work them to aid in understanding. We will discuss them in class. If you perform below expectations on an exam, we will review your worked problem sets as we discuss your performance. Final course grade will be assigned from a student's weighted course average based on percentages and are assigned as follows:

It is essential that you come to class prepared, having already read the chapter(s) that will be covered. The textbook is essential to this course, so you should expect to purchase it. Plan to spend the time and effort to take notes and read your text. I will generally use PowerPoint slides to highlight the topics presented in lecture. However, these slides will **not** be made available. Plan on taking notes and reading your text. Textbook resources are available from the publisher at <u>http://wps.prenhall.com/bp_keown_fof_8/</u> (9th ed. has no website, but the 8th is similar)

Excused absence from a graded item requires written notice personally delivered to the instructor **well in advance** of the scheduled due date. Failure to notify the instructor of an impending absence will result in a score of zero for that item. Notice of an anticipated absence does not guarantee approval by the instructor.

The course has three midterm examinations, with an optional cumulative final exam (replaces lowest or missed midterm grade). While midterms are not designed to be comprehensive, the nature of the material is such that concepts learned early in the course will be required for later coursework. The exams will cover material from lectures, class discussion, problem sets, class handouts, and textbook chapters. Exam format will vary and may consist of objective questions (T/F, M/C), short answer, essay, and mathematical/ graphical analysis.

Pop quizzes cannot be made up for any reason. Excused absence from a pop quiz can get the points waived from the average. Excused absences must be appropriately documented, and should be discussed with the instructor before the absence whenever possible. Exam makeups are not available. For an exam absence, you will be required to take the Final Exam as your third exam grade.

Active participation in class discussions is necessary: therefore, class attendance is required throughout the semester. Absence from class may result in a loss of points for the semester.

If you believe your exam or other coursework deserves a grade other than the one you received, bring it to my attention during office hours. I am happy to entertain a confidential discussion about anything I grade up to <u>five calendar days</u> after it is returned to the class.

I believe that homework is primarily for learning, rather than evaluation. You may work with other students to complete assignments, but you I encourage you to work the problems in such a way that you learn the material. If you can do the assignments without trouble, great. If you struggle, that is <u>your</u> sign that you need to work more problems from the end of the chapter. If you lean on your classmates to complete problem sets rather than do it yourself, your exam grades will suffer, and exams are what count on your course grade. Homework problem sets are not collected. We will have opportunity to discuss them in class.

Violations of SHSU Academic Honesty Policy will result in a grade of "F" for the assignment, and possibly the entire course, depending on the severity of the offense. In accordance with university cell phone policy, if I see a cell phone during an exam, you will receive a grade of zero on that exam. (See SHSU Cell Phone Policy on last page.)
