Text Book

A specific textbook is not required for this course. I will assign readings from publicly available articles to help you prepare for the discussion.

Course Objective

The primary objective of this course is to help the students integrate economic, financial, and strategic management concepts and apply it to analyze the strategic option for Agribusiness firms. The course will use the case study methodology to make the students understand different aspects of the strategic management process and to improve their ability to work in a team environment. This course will also emphasize on the development of important soft skills such as verbal and written communication, teamwork, and leadership.

Expected Learning Outcomes

Upon completion of this course, students are expected to be able to understand the process of scanning the external and internal environment of a business organization, identify the strategic alternatives, and formulate potential strategies. Students will be also able to identify and analyze data sources and function efficiently in teams to achieve the desired objectives.

Assessment of Learning Outcomes

Learning outcomes of this class will be assessed through class participation, class activities, presentation, and final project report. A detailed schedule (tentative) is provided at the end of this syllabus. However, the instructor reserves the right to reschedule the dates if necessary.

Class participation and in-class write-ups

Teaching is not supposed to be a non-stop one-sided monologue. Students are encouraged to ask questions pertaining to the course material and engage in healthy discussions. I will greatly depend on class discussions and act as a facilitator in this course. Hence, the unique contribution from each student is expected to enhance the learning environment. Class attendance is required. If a student misses a class, it is the responsibility of the student to make up anything missed due to the absence. Please see the attendance policy of the Department of Agricultural Sciences and Engineering Technology provided in this syllabus.

The grading in this course is heavily dependent on the group based capstone project, which will be completed mostly during class periods. Hence, individual contribution to the group project through attending class, actively participating in the class activity, and contributing to the preparation of the project is extremely important. Hence, 20% of the grades in this course will be for class participation and class activities. Please remember that this grade is not just for attending the class, but for participating in the group discussion and successfully completing the class activities. Also, remember that this is a writing intensive course and you will complete an in-class assignment in each class. You will be given a score for class participation in each class based on the grade received in these in-class assignments. The lowest 3 scores will be thrown out and the average of the rest will be your score for class participation. Because of the special nature of this class, the following special attendance policy will be strictly followed for this course. These incentives and penalties are over and above the class participation score.

Incentives

If a student does not miss any classes, 4 points will be awarded for class participation. If a student misses 1, 2, or 3 classes, the incentives will be 3, 2.5, and 2 points, respectively. There will be no incentive if a student misses 4 or more classes.

Penalties

If a student misses 5 classes a 2-point penalty will be imposed. The penalty will be 5, 8, 12, 18, and 30 points for missing 6, 7, 8, 9 and 10 classes, respectively. If a student misses 11 or more classes, that student will receive an "F" for this course.

Individual Assignments

Assignment topics will be allotted to each individual. The topics will be various external factors influencing the industry in which your agribusiness firm operates. This well help you have a detailed understanding of the external environment and will become parts of the external analysis write-up of the class project. Individual assignments should be limited to a maximum of 4 pages. The detailed description of the individual assignments will be provided later.

Class Project Report

Please understand that this is a writing enhanced course. The class project (including class activities, reports, individual write-ups, and presentation) will account for 100% of the grade. The class project will be group based. Learning to work as a team is an important learning outcome of this course.

The class project is divided into 4 sections; Internal Analysis, External Analysis, Financial Analysis, and Strategic Analysis. The class will be divided into teams consisting of four or five students each. Each group member will be responsible for overseeing one section. Each group will submit internal, external, financial, and strategic analysis. These sections will be graded and returned to the team with suggestions for improvement. The section for which you are responsible will account for 15% of the grade. The other three sections will account for 10% each. The team will incorporate the suggestions and submit the final project report. For teams with five members, one person will be responsible for submitting the final documents. For four-member teams, the person responsible for strategic analysis will be responsible to submit the final report. The person responsible for each section will be responsible for organizing and submitting the section reports. The final project report will account for 15% of the final grade.

The final project report and reports on each sections will be graded on team basis (i.e. all the members in a group will get the same score for these reports). However, team members in each group will evaluate the contributions of their team members through peer evaluations. Two peer evaluations will be conducted during the course of the semester (the schedule is attached at the end of the syllabus). The individual evaluations will be kept confidential and the average evaluation score only will be disclosed to the individuals in the team. The instructor will also evaluate the work ethics, professionalism, and team work exhibited by each group member. The average of peer evaluation from the group members and instructor evaluation will be used to derive individual scores from the group based class project scores.

The entire class project (other than the individual write-ups on external factors and responding to my comments on write-ups) will be completed in class as various class activities. I have designed the class in the following manner to accomplish this and facilitate intra-group and inter-group communication.

- 1. Students will come to class well prepared after going through the relevant chapter in the text book and assigned reading materials
- 2. I will go over the materials and give detailed instructions on class activity (15 minutes)
- 3. Students will perform the class activity (45 minutes). Usually the class activity will be to prepare a 2-3 page write-up and to prepare 3-5 slides that explain the important points. Groups can get my help if needed to accomplish class activities.
- 4. One student from each group will present the important findings of the analysis to the class (2-3 minutes per group). These short presentations should be rotated among the four team members. These presentations are designed to improve your presentation skills and to make sure that all students understand the various aspects of the analysis.

Class Project Presentation

Members of each group will make a group presentation of the class project, in which all team members should share the responsibility. The presentation will be graded individually and will account for 10% of the final grade. The time allotted for each presentation is 15 minutes. The individuals will be evaluated for clarity of communication, maintaining eye contact with the audience, and exhibiting knowledge on the analysis. *Business professional attire is required for presentation*. All students other than the members in the presenting team will also evaluate the presentations and provide a grade for the presenters.

Attendance Policy of the Department of Agricultural Sciences and Engineering Technology

- 1) Regular and punctual attendance is expected of each student in the Department of Agricultural Sciences and Engineering Technology at Sam Houston State University.
