COURSE DESCRIPTION:

This course provides a general knowledge of construction application as it relates to site preparation, foundation, concrete, wood, and metal construction methods. Emphasis will be placed on the responsibility of general and specialty contractor. Students will be taught cost estimation and procedures for bidding.

COURSE OBJECTIVES/ FORMAT:

After completion of the course, the student will be able to demonstrate knowledge in the following areas:

- Site evaluation, selection and preparation including soil compaction and finishing.
- Excavation and moving of soils
- The principles and procedures of lifting equipment
- Use and handling of concrete paving, foundation and structural applications, and form design.
- The principles and procedures of steel construction.
- Masonry construction, both structural and veneer applications.
- Bid preparation, contract awarding, subcontracts and contract administration.

The course will consist of primarily of lecture and work sessions using Excel. If possible, visiting or observing “hands-on” soil testing, earthmoving equipment/techniques, foundations, concrete construction, wood construction, and metal construction field experiences may be provided.

EXPECTATIONS:

ATTENDANCE has a major influence on participation, project assignments, and presentation. An absence affects all three grading criteria. If a student is absent, they cannot participate. If a student is absent, they cannot exhibit their work. Any assignment not returned by the required time will not be accepted and will not receive attendance for that session.

Every student is expected to be present and **on time** for every class (both lecture and online). In case you are absent, whether excused or unexcused, you are still responsible for the material covered. ***I will feel obligated to disseminate material and instructions one time only.*** If you are absent or late, the responsibility for obtaining handouts and information is incumbent on you. You would be wise to establish relationships with fellow students for assuring that you remain well-informed and that you are adequately prepared for exams.

COURSE EVALUATION:

A **minimum** of three examinations (tests) will be given to determine mastery of course content. Exams will constitute 30% of the total grade while chapter quizzes will be worth 20%. Participation in classroom discussions and participation in outside sessions is worth 20 %. Workbook assignments are worth 30% and represents group and individual projects.

Each unit of study consists of chapter quizzes, workbook assignments, and exams. Missed work or exams may be submitted or made-up when an excused absence is granted. Grading shall be according to the following:

ACADEMIC HONESTY:

The University expects all students to engage in all academic pursuits in a manner that is above reproach. Any use of a telephone or text messagers or any device that performs these functions during a test period is prohibited. These devices should not be present during a test or should be stored securely in such a way that they cannot be seen or used by the student. Even the visible presence of such a device during the test period will result in a zero for that test. Use of these devices during a test is considered de facto evidence of cheating and could result in a charge of academic dishonesty (see student code of conduct <http://www.shsu.edu/students/guide/StudentGuidelines2010-2012.pdf#page=29>).

CLASSROOM RULES AND CONDUCT:

Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
