Course Description:

This course is a video survey for the vast range of dance that has taken place in the 20th century. We will explore dance as an art form and how conceptualizations of "dance" and "art" affect the situation of dance in relationship with other art forms and in society at large. Each week through lecture, reading, watching, and in-class activities, we address a different question about dance as art, including who dances, where dance happens, how we dance, and why we dance.

This is a writing enhanced course. Most often, the information for each unit will be presented on Monday and Wednesday. On Friday, there will be an assignment, quiz or culminating experience covering the unit.

Course Objectives:

- To ignite the students curiosity and excitement about the possibilities of this art form.
- To introduce dance in its many artistic forms: religious, historical, political, social and theatrical.
- To express reactions, thoughts, and ideas about dance in writing.
- To create an original, personal, written definition of Dance, Art and Dance as Art, as perceived by each student. This is a live and working document that will deepen and change as you develop as a dance artist.
- Improve their ability to articulate opinions about dance as an art
- Sharpen their observation and movement analysis skills

ATTENDANCE POLICY

Attendance is necessary in order to receive the information on the topics covered and to complete the assignments, most of which will be completed in class. Attendance will be taken each and every class period. Each absence in excess of three class periods will

lower the student's course grade by **5 percentage points.** No make-up classes will be allowed. Any absence for official university functions may be excused provided that the student requests this accommodation before the absence occurs and presents official documentation. Professional opportunities (at the professors discretion) will be assessed at half an absence. All other absences count toward the total of three.

TARDINESS

Three late arrivals or early exits will be counted as one absence. If the student does come to class late, it is his/her responsibility to check in with the instructor to assure that their presence is properly recorded. Five minutes late will result in an absence.

CASTING POLICY

Casting Policy – Students who make grades lower than B in dance technique classes or an F in any dance major courses will be ineligible for casting in the Dance Spectrum Concert the following semester.

CLASSROOM RULES OF CONDUCT

Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. There is a **NO cellular phone** policy. They must be turned off on put on airplane mode before class begins. If you are caught on your cell phone you will be asked to leave the room and will take an absence. The course grade is based on:

- -10% Daily Participation
 - -Showing up on-time and ready to work and is an active participant in class.
- -15% Dance Concert Attendance
 - The dance concert you are to attend is the Dance Gallery Festival. Dance Gallery dates are October 26-27 at 8pm in the dance theater in the PAC. For this performance, you are to write a short review of the production, no more than 500 words. This assignment is due at the top of class, Monday, October 30.
- -10% Additional shows
 - -In addition to Dance Gallery, you are to attend a Music concert and a Theater (or Musical Theater) production. There is no written assignment for these two shows; it's a pass or fail. You show up and get credit, or you miss it and do not get credit. After you attend your selected show, you have one week from the date of the performance to bring me a copy of your ticket stub and program, showing me proof that you in fact saw the show.
