## **Course Description**

The student is involved in rehearsals for Dance Spectrum, in which dance works by faculty and guest artists, are staged or reconstructed in preparation for major dance program performances.

### **Course Objectives**

- 1. To gain practical experience in the rehearsal process
- 2. To develop skill in artistry and performance
- 3. To deepen range of artistic expression
- 4. To develop stage etiquette and to experience protocol and procedures common in the profession

### **Course Requirements:**

- 1. By accepting casting in a work, the student accepts the posted rehearsal schedule, as well as production meetings, technical rehearsals, dress rehearsals and the performance.
- 2. Students must promptly attend all rehearsals as scheduled. If a student is unable to attend, it is their responsibility to notify their choreographer as promptly as possible.
- 3. Students are responsible for checking the call boards and their emails regularly for DNC 4330 information
- 4. Students are required to participate in company class prior to tech/dress rehearsal and performances. This is not an option.

### **Attendance Policy**

3 hours of absence are permitted without penalty to the final grade. Students enrolled in this course are active participants in the creative process. Creating work without a full cast puts a burden on the choreographer. If a student must be absent, prompt notification to the choreographer is required. Unexcused absences will affect the student's grade, and may result in the student being removed from the dance by the choreographer. Prolonged injury or illness that necessitates non-participation may require that the student drop the course.

Unexcused absence from any of the following will lower the final grade by at least 10% for each occurrence:

- \* Production meetings
- \* Technical Rehearsal
- \* Dress Rehearsal
- \* Participation in Company Class prior to dress rehearsals and each performance

Unexcused absence from a performance will result in a grade of F.

## Grading

- Qualitative grade for the rehearsal process assigned by student's choreographer(s). If the student is cast in multiple works, the individual choreographer's assessments will be averaged.
  Demonstration of appropriate professional behavior in technical and dress rehearsals as well as during the run of the performance
- 40% Demonstration of technical and artistic qualities in the performance

#### STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
