COURSE DESCRIPTION

This course provides a chronological survey of the major monuments of painting, sculpture, architecture, textiles, and metalwork from the medieval period to the present. Prerequisite: None. Writing Enhanced.

COURSE OBJECTIVES

After completing this course, students will be able to demonstrate:


1. Identify and describe works of art based on their chronology and style, using standard categories and terminology.
2. Investigate major artistic developments and significant works of art from the 14th century to the present day.
3. Analyze the relationship of art to history by placing works of art within cultural, historical, and chronological contexts.
4. Explain the impact of individuals, historical events, religious and philosophical concepts on art making in various periods

METHODOLOGY

This course will be taught through online assignments that include reading, discussions, and Quizzes. Exams will cover material presented in assignments and the text and short audio lectures.

ATTENDANCE IS MANDATORY

Students are required to log in to the online course every week during the semester to receive assignments, participate in discussions and turn in work.

Weekly Units will be available for one and half weeks, from Wednesday until Friday of the following week.

Assignments will be posted every Wednesday and be due Friday of the Following Week .

GRADING POLICY

This course will be composed of three categories.

- 1. The Weekly Units** will include reading assignments from the textbook and online sources, and assigned viewings of films. Each Weekly Unit will conclude with a discussion, a short quiz or an assignment.
- 2. The Research Unit** consists of researching an assigned artist in order to participate in a social media experiment. The assignment will be ongoing throughout the semester and will start once you have been assigned an artist to research.
- 3. Exams.** There will be 4 Exams during the semester. Exam questions will be taken from the reading assignments presented in the PowerPoint presentations as well as any supplementary audio/video provided. The lowest of the four online exams (not including the final) will be dropped before the final average is tallied.

I will communicate with the class via email, so **you must check your SHSU email account daily**. I will also be adding notifications, information of interest (such as upcoming art events, interesting news stories, etc.)

I will respond to your emails within a 48 hour period. You are responsible for any notifications that are sent to that email address regarding this course.

Discussion board, quiz and assignment grades will be posted prior to the following assignment.

The final grade in the course will be determined by the following formula:

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion

whose places of worship are exempt from property taxation under Section 11.20....” A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed. DEPARTMENT OF ART BFA REVIEW

The purpose of the BFA Review is to ensure that students have learned basic principles and techniques needed for advanced art courses.

All Art students must successfully complete all of the Art Foundation courses and the BFA Review before being accepted into a BFA program in Computer Animation, Photography, or Studio Art or Graphic Design. Graphic Design students must also pass a separate Graphic Design Review after the BFA Review.

The Art Foundation Courses are WASH, Drawing, and Foundations in Digital Art. (ARTS 1313, 1314, 1315, 1316, & 2313). Students must pass each course with a grade of C or higher to take the BFA Review and proceed to upper level courses.

The semester after all of the Foundation courses are complete, students must sign up for the BFA Review. Students should see an art advisor every semester to ensure they take the BFA Review on time. It should be taken the semester immediately following the completion of the Foundation Courses.

Students who do not pass the BFA Review may re-take it the following semester. Students who do not pass on the second attempt will not be allowed to continue as BFA majors, but may follow the degree plan for the BA in Art. Non-participation after signing up or being advised to sign up will count as a failure of that semester's review.

Graphic Design students must pass the BFA Review, complete Principles of Graphic Design (ARTS 2323) and participate in a BFA Review at the end of the semester that they are enrolled in Typography (ARTS 3322).
