### **Course Description**

Museum and Gallery Practices is a course that examines the role of the Art Museums and Galleries in the "Art World" and in society in general. Students will study different types of exhibition spaces and learn how they operate. In the course, students will curate and organize public exhibitions of art, and promote the exhibitions to the community. Students will learn the proper way to handle and store artworks and to prepare them for shipping and exhibition. Exhibition design and curatorial practices will be examined as well as the role of art critics and the press.

This course has been designated as an ACE course. The ACE designation means that the course includes Academic Community Engagement. Students will not only learn knowledge and skills, but also actively use them to make a difference in the community to improve the quality of life. This experience, it is hoped, will help each student see themselves as a positive force in this world and deepen their understanding of their role as a citizen.

# **Course Objectives**

At the conclusion of this course, Students should

- ·know what to expect from a Museum or Gallery exhibition
- · be able to identify different types of Museums, Galleries and Exhibition Spaces
- ·understand the roles of the various staff of Museums and Galleries
- ·know how to pack, ship, handle and hang works of art
- · be able to contact artists, visit artist's studios and evaluate artist's work
- · be able to organize an exhibition of art
- · be able to write a press release and make a printed announcement to publicize an exhibition
- · understand the role of the art space in the community

#### Methodology

The course will be taught through lectures and presentations of visual materials. Assignments and readings will be posted on Blackboard. The class will take several field trips throughout the semester, to museums and galleries in Houston. The SOFA gallery and the SHSU Satellite Gallery in the art department, and the LSC gallery in the Lowman Student Center will be used as laboratories. Students will participate in organizing and installing exhibitions in these spaces.

Students will do research projects on museums, galleries and alternative art spaces, and participate in Discussion Boards and keep an online journal or blog of their projects on Blackboard. The class, as a group project will curate and mount an exhibition of art. Students may also work with artists exhibiting in the Gaddis Geeslin Gallery and the Satellite Gallery.

Students will engage with the community by volunteering at a non-profit arts organization or school in the Huntsville/Houston area. Each student must volunteer a minimum of 9 hours. The Wynn Home Arts Center in Huntsville, Lawndale Art Center, Diverse Works, and BOX 13 ArtSpace in Houston all depend on volunteers to make their exhibitions possible. Students have also served as jurors of art shows at public schools in Conroe and other municipalities. The Gaddis Geeslin Gallery in the Department of Art is also an option.

### Assignments, Exams and Grading

# Class Participation in Field Trips and Community Service

This class requires participation in field trips to Houston, and possibly Dallas, and Austin or other locations. Students in the class are required to participate in these field trips and are responsible for the costs of travel. All efforts will be made to keep costs to a minimum. Most of the trips will take place on Fridays during class time, but will sometimes extend beyond the regularly scheduled class time. There may be one field trip that will require overnight stays in Dallas or Austin on a weekend. In addition to the field trips, students will be required to volunteer at a local non-profit arts organization or school. A minimum of 9 hours service is required. Missed field trips can be made up by additional service time.

### Class Journal

Students will keep a journal to document their visits to museums, commercial galleries and alternative art spaces. Included will be written and photographic material from exhibits, students' impressions of exhibitions and gallery spaces and the three reports:

Museum Research Commercial Gallery Research Alternative Space Research

#### **Community Service Report**

Students will keep a journal describing their experience volunteering at a community non-profit arts organization or school.

### **Exhibitions**

As a group, the class will curate and hang 3 or more art exhibits. Students will participate in all aspects of the exhibit including writing press releases, advertising, selecting art works, installing art works in gallery and lighting the exhibition.

Class participation includes class attendance, field trip participation, and contributions to group projects.

In this class 100-90=A, 89-80=B, 79-70=C, 69-60=D 59-0=F.

Grades for presentation and papers will be based on the thoroughness and accuracy of the research and organization of the material. All work must be turned in on time for full credit.

The grade of **C** is considered average. If work meets the minimum stated requirements for the project, it will be considered average in terms of design, concept and craft. Work that exceeds that basic expectation will have points added and fall into the **B** range, and exceptional work will earn an **A**. Work that fails to meet the minimum criteria for the project will receive **C-**, **D**, or **F**.

# Make Up Work

Students may make up assignments or missed projects with permission from the instructor if documentation of illness or other uncontrollable events are provided. Make up work must be completed immediately upon return to class.

# Attendance is mandatory

According to University policy, a student may miss 3 hours (that's one class period) before their final grade is affected. This class will often meet for trips and events outside of class time, so classes may be abbreviated or rescheduled to compensate for this time. Field trips are required. In this course, you may miss two class periods before your final grade is affected. Use your absences wisely. I suggest saving them for when you are sick or in jail. Please do not ask me if you can miss class for personal reasons. If you have 3 absences, your final grade will be lowered 5 points, 4 absences –10 points, 5 –15, 6 –20, 7 –25. If you miss more than 7 classes, you will not pass the course. Students who are more than 20 minutes late will be counted absent. Students are expected to remain in class the entire period. You are responsible for all assignments and information given in class even if you are absent.

# Academic Dishonesty (Academic Policy 3810213)

All students are expected to engage in all academic pursuits in a manner that is above reproach. #### Visitors in the Classroom

Only registered students may attend class. Exceptions can be made on a case-by-case basis by the professor. In all cases, visitors must not present a disruption to the class by their attendance. Students wishing to audit a class must apply to do so through the Registrar's Office.

Student Absences on Religious Holy Days Policy (academic policy 3 861001)

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed. # **Defacing University Property**

Defacing University property is prohibited by University policy. It is also a criminal offence. Students will be held responsible for the cost of damages to the facilities. Violations will be reported to University Police.

Students should not paint on concrete, asphalt, trees, sides of buildings, interior walls or floors of buildings, locker doors, etc. When using any kind of paint use a drop cloth or tarp to protect the surface from overspray.

### Department of Art BFA Review

The purpose of the BFA Review is to ensure that students have learned basic principles and techniques needed for advanced art courses.

All Art students must successfully complete all of the Art Foundation courses and the BFA Review before being accepted into a BFA program in Computer Animation, Photography, or Studio Art. Graphic Design has a separate BFA Review.

The Art Foundation Courses are WASH, Drawing, and Foundations in Digital Art. (ARTS 1313, 1314, 1315, 1316, & 2313). Students must pass each course with a grade of C or higher to take the BFA Review and proceed to upper level courses.

The semester after all of the Foundation courses are complete, students must sign up for the BFA Review. Students should see an art advisor every semester to ensure they take the BFA Review on time. It should be taken the semester immediately following the completion of the Foundation Courses. (Generally, the semester after Life Drawing 1.)

Students who do not pass the BFA Review may re-take it the following semester. Students who do not pass on the second attempt will not be allowed to continue as BFA majors, but may follow the degree plan for the BA in Art. Non-participation after signing up or being advised to sign up will count as a failure of that semester's review.

Graphic Design students must complete Principles of Graphic Design (ARTS 2323) and participate in a BFA Review at the end of the semester that they are enrolled in Typography (ARTS 3322).
