Course Description

This course introduces core-programming basics including data types, control structures, algorithm development, and program design with functions—via the Python programming language. The course discusses the fundamental principles of Object-Oriented Programming, as well as in-depth data and information processing techniques. Students will solve problems, explore software development challenges, and create practical and contemporary applications.

Course Goals

At the end of this course, the student should be able to:

1. Solve problems, explore real-world software development challenges, and create practical and contemporary applications.
2. Analyze and identify information security problems, and define common methodologies used to secure computer systems.
3. Use the current techniques, skills, and tools necessary for computing practice.
4. Develop programs using python programming language.

Course Contents

- Algorithms and Information Processing
- Control Structures
- Boolean logic and Numeric Data Types
- Strings, Text Files, Lists, and Dictionaries
- Objects and Classes
- Simple Graphics and Image Processing

Late Policy

Penalty for late work is 10% of the worth per calendar day late, unless an extension (for a valid reason) has been granted in advance. The maximum period to deliver late work is two days with penalty of 20% deduction of the total. After two days, no late work will be accepted.

In addition, it is not permitted for students to use code examples provided by the instructor without appropriate documentation/ citation of the use of that code.

Attendance Requirements

Students are expected to attend all class sessions. You are responsible for all material covered in every class, regardless of whether you attended or not. It is your responsibility to obtain notes, assignments, etc., from fellow class members if you miss a class.

Classroom Conduct

Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university.
