EVALUATION PROCEDURES:

- **♦ Homework (15%):** Homework will be assigned as sections are completed in lecture. Homework due dates will have one class day between assigning and turning in (i.e. if assigned on Monday → due Friday)
- ❖ Quizzes (15%): Quizzes will be given at least once a week, unless otherwise noted in the last 10-15 minutes of class. It is an incentive to keep up the concepts gone over in class. Occasionally, the quizzes will instead be group work done in class. The will be NO make-up quizzes given (so come to class each day), but your lowest quiz grade is dropped at the end of the semester.
- **❖ Unit Exams (15% each):** There will be three unit exams during the semester, for a total of 45%.
- ❖ Final Exam (25%): The final exam will be comprehensive. It is NOT optional. If it is beneficial, your final exam grade can replace your lowest unit exam grade.
- **❖ Make-up Policy:** You <u>cannot</u> make-up an exam, homework assignment or quiz. Missing assignments are given zero points.

Attendance: You should attend all classes and are responsible for all notes, announcements, assignments, quizzes, and exams. If you must miss class, notify me via email as soon as possible as to why you were not in class or will not be attending class. An absence is excused only in cases of medical emergencies, death in the family, or school sponsored events. To excuse an absence, you must provide legitimate documentation (for example, a doctor's note or official university excuse) no later than the day that you return to class.

Academic Dishonesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. Classroom Rules of Conduct: Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Students are prohibited from using tobacco products in class, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Use of Telephones and Text Messaging: Cellular telephones must be turned off before class begins. Student Absences on Religious Holy Days Policy: Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable time frame in which the missed assignments and/or examinations are to be completed.
