4. Course Description: The calculus sequence is a unified introduction to the fundamental concepts, skills, and applications of calculus and analytic geometry. Topics include the definite integral and its applications, techniques of integration, improper integrals, Taylors formula, and infinite series

Prerequisite: Math 1420 with a grade of C or better.

The class will be primarily lecture-oriented and usually consist of a question period at the beginning and then a lecture. Group work and presentations by students at the blackboard will also be expected.

- 5. Course Objectives: You will have a basic understanding of limits, continuity, differentiation, Riemann integration, and infinite series and be able to apply these concepts to problems and present answers in a logical manner.
- 6. **Required Textbook:** Calculus, Early Transcendental Functions by Larson and Edwards, 6e. We will cover all or parts of chapters 5, 7, 8, 9, and 10.
- 7. Required Supplies: A graphing calculator is expected. I have and will be using the TI-84 Plus. Calculators with computer algebra systems will not be allowed. Ask me, if you want to know if a certain type of calculator is acceptable. You will need at least three blue-books.
- 8. **Attendance Policy:** You are expected to attend every class *and to arrive on time*. If class must be missed, then you are expected to get the notes and homework assignment from a classmate.
- 9. Assignments:
 - (a) **Homework:** Homework will be assigned almost every class period and *collected periodically*. It is your responsibility to ask questions about homework problems that you were not able to complete or did not understand.
 - (b) **Quizzes:** A weekly quiz, based upon the assigned homework and lectures, will be given. At times, you will be allowed to use your homework solutions for your quiz. Thus you should bring your homework, neatly written and organized, to each class meeting. *There are no make-up quizzes*, but (at least) your lowest quiz score for the semester will be dropped.
- 10. **Exams:** There will be two exams during the semester and then a final exam. The first exam will be given soon after chapter 7 and the second after chapter 8. You will be notified in class at least one week before the exam date.

There are no make-up exams. The percentage on the final exam can be used to replace your lowest exam score. The final exam is Wednesday December 6, 2017 from 12:00 - 2:00 p.m. It will be comprehensive.

- 12. Academic Dishonesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. - 13. Classroom Rules of Conduct: Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins and cannot even be visible during an exam. The visible presence of such a device during the test period will result in a zero for that test. Students are prohibited from using tobacco products in class, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.
- 14. **Visitors in the Classroom:** Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.
- 15. **Religious Holidays:** Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.
