Course Description: Topics include the definite integral and its applications, techniques of integration, improper integrals, Taylor series and infinite series, polar coordinates.

Attendance Policy: Regular and punctual attendance for this course is mandatory and will be recorded throughout the semester. Any late homework will be counted as "incomplete." A brief in-class quiz based on the homework will determine the final homework grade. Homework with a grade of "Complete" will contribute 40 points to the 100-point quiz. Homework with a grade of "Incomplete" will contribute 20 points to the 100-point quiz.

Quizzes: Regular quizzes will be administered during <u>each</u> class period. These quizzes will be based on the homework assigned and will be carefully graded. Your work on the problems in the quiz will contribute a maximum of 60 points to the 100-point quiz. Bottom line: Do Your Homework and Hand It In!
