# **Course Description**

This course will provide a basic overview of crime and the criminal justice system in the United States. It will include discussions on criminal justice philosophy, policies, practices, and trends. In the end, it is hoped that students will have a better understanding of the essential components of the criminal justice system (citizens, law enforcement, courts, corrections), and the emerging topics and trends related to these.

#### **Course Objectives**

- 1. Define crime, deviance, and social control, and explore how these interact and relate.
- 2. Explore theories and methods that are used in criminal justice decision-making.
- 3. Analyze how criminal justice policies are created, implemented, and enforced.
- 4. Discuss and evaluate the history and evolution of the criminal justice system.
- 5. Evaluate current events and trends affecting the criminal justice system.
