**Material Covered:** Topics include chi-square goodness-of-fit testing and inferences concerning location and scale. Specific tests include the sign test, Wilcoxon signed-rank test, the Kruskal-Wallis test, tests for randomness and trends, and contingency analyses

**Learning Outcomes**: At the conclusion of the course students will have a clear understanding about the above topics with the ability to apply the techniques in real-world problems.

Attendance: Class attendance is extremely important to succeed in this course. Roll will be taken at class meetings. Two extra points will be added to the overall score for the students having NO more than 2 absences for the semester. Late arrival, leaving class early and forgetting to sign the roll sheet are counted as absences.
