### **Course Description**

This course examines the constitutional and statutory bases of laws, and the judicial interpretations of the procedures governing the administration of criminal justice and police practices.

### **Course Objectives and Goals**

At the completion of this course, students should accomplish the following:

- an understanding of the exclusionary rule and probable cause
- an understanding of judicial interpretations involving arrests, searches, and seizures
- an understanding of the laws regarding interrogations and confessions
- an understanding of constitutional rights during trial
- an understanding of the consequences of unlawful police conduct

### **Exams**

There will be 3 exams worth a total of 300 points. They may be multiple choice, short answer, fill in the blank, identifications, and/or essay. Each test will cover all material presented in the texts, handouts, videos, and presented in lecture. Study guides will be provided prior to all exams. I do not provide word banks, word lists, or definition lists.

### **Attendance and Participation**

I will take attendance by way of a sign-in sheet each class day. After 2 absences, you will lose 10 points for each additional absence. I also will keep track of all students who actively participate in class discussions and ask questions. Therefore, I strongly encourage all students not to miss class. In addition:

- Students may miss valuable information for exams from lectures and discussions, and as exams are drawn heavily from lectures, missing class will negatively impact your score.
- If you miss class on the date a brief is due, you will receive a zero score for that brief.
- Students may miss extra credit quizzes.
- Students will miss out on participation points
- Students that miss more than 5 class sessions may be administratively dropped according to University Guidelines.

Note: Having another student sign in for you is the same as cheating since it involves points and a grade. Doing so may result in a grade of F for all students involved.

### **Case Briefs**

Each student will do 4 briefs on cases listed in the text, and they are worth 25 points each for a total of 100 points possible. Each student will have a U.S. Supreme Court case to brief from the chapter being discussed at that time in class. We will discuss the format and requirements in class. Late briefs will not be accepted, nor will they be accepted by email. They are due IN CLASS, on the day noted in the schedule. NO EXCEPTIONS.

### **Academic Honesty**

I regret that I should even have to mention the issue of cheating, but here it is: If I catch you, the very least you can expect is an F. Honor and integrity is the very core of Criminal Justice and I value my profession and its reputation very highly.

### **Extra Credit**

Throughout the semester, I may have several unannounced quizzes. Each will be worth 5 points. (Five questions worth a point each). At the end of the semester, I will add any points that you have earned to your final score. Obviously, if you are not present, you will miss the quiz and the opportunity for extra points. There are no make – ups under any circumstances on quizzes.
