Course Description: National income concepts and measurements; analysis of the factors influencing the level of national income, employment, price, and production; and application to current problems.

Learning Objectives: After completion of this course, the student will have learned to:

- to describe basic macroeconomic terms, data, and relationships such as real versus nominal GDP, unemployment, inflation, etc.
- to employ simple models to describe the determinants of income and output growth over the long run.
- to explain the determinants of aggregate demand and its effect on GDP in the short run, and the transition of GDP from the short run to the long run.
- to use macroeconomic models to explain the effects of policy in a closed and open economy.
- to identify the effects of policy given the potential inflation-unemployment trade-off in the short run.
- to understand the link between savings, investment, government deficits, and foreign trade.

Further, students should learn to apply course material to understand “real world” economic problems and critically evaluate economic ideas, arguments, and points of view.

Course Goals: The students should make progress on:

- Gain a basic understanding of the subject (e.g. factual knowledge, methods, principles, generalizations, theories)
- Develop specific skills, competencies, and points of view needed by professionals in the field most closely related to this course
- Learning to apply course material (to improve thinking, problem solving, and decisions)

This grading scale is subject to change, but the cut-offs will never be raised. ***No extra-credit will be given. You are responsible for properly completing each assignment and submitting them promptly. You will receive a final grade of F if you miss more than one exam.***

Exams: All exams will consist of multiple choice and/or short answer/essay questions and include material covered in class and material in the required text. A Scantron form 882-E is required for all multiple choice exams. Failure to use the appropriate scanform will result in a reduction in your exam score. Cell phones and graphing/programmable calculators may not be used during exams for any reason. You may only use a non-programmable, four-function calculator for exams. The student is responsible for clearly annotating answers on their scanforms. Any errors found, after grading, will not be reversible. Therefore, the student should take the time to double-check their scanforms. If a student has a dark erasure or any other mar that may inhibit grading or create errors in grading, notify the instructor as the exam is turned-in, and the instructor will hand grade the exam.

When computing your final average, the lowest exam score (excluding exams where the student is caught cheating) will be omitted. ***No make-up exams will be given.***

Homework/Quizzes/Other Assignments: Homework / Quizzes / Other Assignment will consist of multiple choice and short answer/essay questions and homework/quizzes can be unannounced. ***Late homework / quizzes / other assignment will not be accepted and make-up homework / quizzes / other assignments will not be given. If you are late to class the day homework/quiz is assigned, you cannot turn-in that homework / quiz / other assignment – you will receive a zero. There are zero exceptions to this policy.*** If you cannot attend class, you can turn-in your homework / quiz / other assignment via email or voicemail only before the start of class on the date the assignment is due. Homework / quiz / other assignments sent via email/voicemail must be received before the regular class meeting. This policy is intended for emergencies - if you abuse this policy and have excessive absences, your homework / quiz / other assignment will only be accepted at the beginning of class and be contingent upon your attendance for that class. If you turn-in your homework/quizzes via any other method than that listed above, i.e. class turn-in, email or voicemail, you will receive a zero for that assignment. For example, I will not accept a homework / quiz / other assignment that is placed under my door. This policy may be changed at the instructor's discretion as needed during the semester.

A Scantron form 882-E or 815-E may be required for homework/quiz assignments. Failure to use the appropriate scanform will result in a reduction in your exam score. Cell phones and graphing/programmable calculators may not be used during exams for any reason. You may only use a non-programmable, four-function calculator for exams. The student is

There are no make-ups for these quizzes. The quizzes will cover any material already presented during the semester and/or to be presented for the day.

Any behavior deemed suspicious (at the instructor's discretion) will result in: 1. verbal warning, 2. reassignment of testing location, or 3. a grade of zero that will not be dropped when calculating final grades.

Class Attendance Policy: Students are expected to attend *all* classes. Regular and punctual class attendance is expected of each student. Students that are late for class will be counted as absent. Further, active participation is expected, and those that do not actively participate (at the instructor's discretion) will be counted as absent. ***Absent students or students that arrive late to class may not turn-in homework/quiz assignments that are due or make-up homework/quizzes.*** You must notify the instructor in advance if a prolonged absence is imminent or expected. You may be allowed to take a scheduled exam early at the instructor's discretion. Further, if you are having difficulties that might interfere with your performance in this class, notify your instructor immediately.
