### **COURSE DESCRIPTION:**

This course is designed to introduce students to the three broad categories of statistical techniques: Descriptive statistics, measures of association, and statistical inferences. Lectures, assigned readings, in-class exercises, and homework assignments will be used to describe and illustrate the logic, interpretation, and basic assumptions of various statistical techniques. To further enhance the learning process, Statistical Package for Social Sciences (SPSS) is also adopted to analyze the data. All students are also required to register the online lab section (SOCI3443.04).

### **COURSE OBJECTIVES:**

1. To gain factual knowledge and to provide a clear and detailed step-by-step illustrations of statistical techniques taken up in this course.
2. To learn how to apply course material to improve thinking, problem solving, and decision making.
3. To learn how to find and use resources for answering questions or solving problems.
4. To learn how to use data in the SPSS statistical package, to compute statistics using SPSS, and to interpret the statistical outputs from SPSS.

### **REQUIREMENTS:**

**Class Attendance (4%):** Following University policy pertaining to class attendance, regular attendance is expected of each student. Particular in borderline cases, exceptionally fine or weak class involvement will be considered in the calculation of the final grade. The highest class attendance grade is an "A" and this allows up to six hours absence.

**Homework Assignments:** There will be **twelve** homework assignments (2% each). The homework will be a combination of pencil and computer exercises. **You will be allowed to drop one lowest homework assignment grade at the end of the semester and replaced with the highest assignment grade.** Homework is normally due at one week after it is given. **NO LATE HOMEWORK.**

**Exams:** There will be **FOUR major exams (19% each)**. All exams are open books and open notes. Specific dates for exams will be announced in the class as the course progresses. The student is allowed to make up one missed exam if she or he receives consent from the instructor before the exam. **Any makeup exam will be held at the end of the semester and is a comprehensive exam.**

You should get about 90% overall for an "A", 80% for a "B", 70% for a "C", and 60% for a "D". The cut-offs, however, are flexible and I may change them at the end of the semester if I consider it necessary.
