# Beginning Acting

<u>Course Description</u>: A study of basic techniques in body and voice as they are applied to the performance of an actor. We will explore the craft of acting through vocal and physical warm-ups, ensemble improvisation, character analysis, and imagination work. We will explore generosity on stage, learning to listen to a scene partner, as well as finding the joy in performance.

<u>Course Objective</u>: Learn how to create a character using both your body and voice. Learn to identify character objectives. Learn how to live privately in public.

<u>Classroom Attire</u>: Please wear comfortable and non-restrictive clothing. I encourage you to dress character appropriately when presenting your scenes.

<u>Classroom Demeanor:</u> This is NOT a lecture class. We learn by doing. Come to class focused and ready to move, interact, discuss and perform. You will be asked to work alone as well as with others. NO CELL PHONES, TABLETS, OR COMPUTERS IN CLASS. If you are caught texting or the like in class, your grade will be reduced. Please don't. No Classroom Visitors.

If a cellphone rings, dings, etc. during class, EVERYONE does 20 push-ups. SILENCE YOUR PHONES! If my phone goes off, I do 20 push-ups.

The classroom is a space in which many ideas and opinions are expressed and discussed. I ask that all students show respect, sensitivity, and discretion with each other and the topics that may be discussed in the classroom.

**Required Reading:** No Textbook required, but you will have plays and other readings posted as PDFs to Blackboard.

### The following texts may prove helpful or interesting to the student:

Attendance Policy: The only way to learn is to be present and active in class. I do take roll. Everyone gets one free absence. Use it wisely. Three unexcused absences will result in the lowering of your final grade by an entire letter (i.e., A will become B, etc.) Six or more absences will be an automatic F. Tardiness is unacceptable. If you are tardy three times, that equals one absence. Excessive tardiness will result in a reduction of your final grade.

**Participation (50 pts):** The only way to learn is to be present and active in class. I do take roll and attendance/class participation are parts of your final grade. However showing up won't cut it. You will need to take an active role in the class execerises, dicussions, and be a generous classmate. (2 pts per class)

**Monologue (75pts):** You will select a monologue, which will be performed, fully memorized, and physicalized for the class. Details of the assignment will be given.

**2 Mintues of Life (50 pts):** Using Uta Hagen's Object Exercises you will re-create 2 minutes of your life and bring it to life as if for the first time. Details of the assignment will be given.

**Performance Response (150pts total, 50 pts each)** All students are required to attend the following Department of Theatre and Musical Theatre 2016 productions: <u>Silent Sky</u>, <u>The Government Inspector</u>, and <u>Oklahoma!</u>. Each student must write a minmum 500 word response per show. (These <u>must</u> be typed and printed. NO EMAILS) These papers will focus on how the show impacted you. You may write about how an actor used his/her body, voice, and movement to tell the story. You will have a chance to learn by watching and assess how the actors have applied what we study in class. PLEASE DO NOT GIVE ME A SUMMARY OF THE PLAY. All responses must be turned in at the beginning of the first class period after a show closes. If the response is not turned in by the beginning of class, you will be given a ZERO for the assignment. **Respones will not be accepted at a later date.** 

**Scene 1 (175pts Total, 100pts Scene & 75pts Character Analysis):** You will partner up with a classmate of your choice and together you will select a scene from a comic or seriocomic play. After your scene is approved, you will work with your classmate on the scene both

inside and outside of the classroom. You will present the scene memorized, rehearsed, and staged for the class. You will also create a written character analysis for the character you are portraying. Details of the assignment will be given.

**Scene 2 (200pts Total, 125pts Scene & 75pts Journal/Research):** You will be assigned a scene from a play. You will be assigned to work with a different classmate on the scene both inside and outside of the classroom. You will present the scene memorized, rehearsed, and staged for the class. As you work on your scene, you will create journal entries as the character you are portraying. You will also present research from the world of your play. Details of the assignment will be given.

Scene 3 (300pts Total, 225pts Scene & 75pts Character Collage): You will be assigned a scene partner and together you will select a scene from a play and genre of your choice. After your scene is approved, you will work with your classmate on the scene both inside and outside of the classroom. You will present the scene memorized, rehearsed, and staged for the class. You will also create a character collage representing the life of your character. Details of the assignment will be given.

#### \*\*\*A Note about Scene Work\*\*\*

Much of your grade will be based on partner work. You must be available to work with a partner in the rehearsal process, both in the classroom and outside the classroom. If you are unavailable to work with your partner, your grade will be lowered. Please make an effort to meet and rehearse your scene. You will be thankful you did. If <u>you</u> do not show up on the day when your scene is due to go up, <u>you</u> will be given an automatic ZERO for your scene. Your partner will not be penalized. Scenes are presented to the class and then reworked. Your grade is based on both the initial and the reworked performance.

If the student is unable to complete course requirements, the student's grade will reflect this.
