A graphing calculator or scientific calculator is required for use on tests and quizzes. I recommend a Texas Instruments TI-84 Plus or TI-83 Plus graphing calculator, but there are many other fine calculators available. Cell phones and any other device with wireless communication capabilities are not to be used as a substitute for a calculator on exams or quizzes. Sharing calculators during a test or quiz is considered cheating.

Use of communication devices, such a cell phone, during a class is disruptive. Turn the sound off or turn the device off during all classes and put them away during quizzes and exams. In the event of an emergency situation where use of communication device is necessary please inform your professor before class.

The three exams are tentative scheduled for Monday 25 September, Monday 23 October and Wednesday 15 November. The final exams are tentative scheduled Wednesday 6 December 2:30-4:30pm (sect. 1), Wednesday 6 December 12:00-2:00pm (sect. 5). Each of the four exams will count the same. If it is to your benefit, the final exam will count as one of the four exams and replace the lowest of the first three exams. Bring your valid picture ID to each exam.

Short quizzes and homework occur occasionally and will be factored into the corresponding exam grade. Neatness counts on homework. Homework is due at the beginning of class.

Students should plan for no make-ups quizzes and homework. Make-up exams **may** rarely be approved with documented proof of a significant emergency. The final exam grade may substitute for a missed exam grade.

Students are expected to check Blackboard and SHSU e-mail at least daily.

Students should behave in ways that will not disrupt the learning process in class.

Cameras and recording devices are not permitted without my prior permission.

The syllabus is subject to change. Changes will be announced in class.

#### ATTENDANCE:

All students are expected to attend class and participate in class. It is important to arrive on time. Bring a notebook and take notes of the discussions and examples presented in class.

## VISITORS IN THE CLASSROOM:

### STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s) by Wednesday 13 September 2017. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
