Course Description

It is essential that criminal justice professionals be socially aware of the cultural differences in society, and the importance of the perception of fairness in how the criminal justice system creates, enforces, and carries out policy and justice. Research in criminal justice and criminology often points out the disparate rates at which minorities are involved in the criminal justice system. The focus of this course will be to examine multicultural issues in the realm of criminal justice and society.

Course Objectives

1. Analyze the interactions of class, race/ethnicity, and gender in relation to criminal justice policies, actions, responses, and outcomes.

2. Explore theories, roles, and/or methods concerning the interaction of the criminal justice system with a diverse, multi-cultural population.

3. Understand the nature of the link between crime policies and class, race/ethnicity, and gender.

4. Evaluate current events relating to minority interactions with the criminal justice system.
