# **Course Description and Objectives:**

This course is a study of the organization, functions, and administration of the several branches and bureaucracy of the Texas state and local government, including a study of the numerous Texas constitutions. The primary factors considered relate to the three branches of government – judicial, executive, legislative – current Texas Constitution, events that shaped the state, and current events. Emphasis is placed on the interaction of these subsystems.

# **Course Assessment:**

#### Exams:

There are four, in-class, closed book, no notes, exams and an optional final exam. All exams during the semester are essay exams. The essay question is provided in advance. There are <u>NO</u> opportunities to earn extra credit points on these exams.

#### **Exam Review:**

Time is set aside during regular class meetings for review prior to exams. You are urged to bring specific questions on review days.

#### Final Exam:

You are required to take the cumulative final exam in this class. However, if your final exam score is higher than your lowest in-class exam score your final exam grade replaces the lowest exam grade. You may replace only one (1) of the four exam grades with the score of the final exam. You may replace a score of zero (0) with your final exam score. If your final exam score is lower than all four of your in-class exam scores, the final exam score is discarded.

## Make-Up Exam Policy:

You are expected to take the exams at the scheduled times. There are <u>no</u> opportunities to make up exams in this class. Your final exam score substitutes for any and all of the exams you miss during the semester.

## Writing Assignments:
