Purpose of Course

This course is designed to introduce students to the logic and character of scientific and alternative means of social inquiry. Topics such as the foundations of research, sampling, measurement, design, and analysis are explored in detail.

Course Objectives

Upon completion of SOCI 4340, students will have developed the specific skills, competencies, and points of view needed by social scientists who conduct applied research.

In addition, students will have increased their understanding of the numerous qualitative and quantitative research methods used in the social sciences.

General Education Objectives

Upon completion of this course, students will have:

- developed specific skills, competencies, and points of view needed by professionals in Sociology; and,
- learned to apply course material (to improve thinking, problem solving, and decisions).

General Course Structure

Although some material will be presented in traditional lecture format, the course will be primarily conducted as a seminar. As such, the focus of the semester's work will be on reading, assimilating, writing about, presenting, and discussing material on issues related to social scientific research. Therefore, you must come to class prepared to participate. Class participation is an essential and expected component of the class.

Required Books and Assigned Readings

You are expected to purchase the following book:

Frankfort-Nachmias, Chava, David Nachmias, and Jack DeWaard. 2015. *Research Methods in the Social Sciences*. New York: Worth.

NOTE: I may assign and supply additional readings throughout the course.

Requirements and Grading

Part of the tradition of higher education is the need to evaluate performance. Your final course grade will be based upon your performance on each of the assigned tasks.

Class Participation (expected)

Active participation is an essential and expected component of this course. Although some material will be presented in traditional lecture format, the course will be primarily conducted as a seminar. The focus of the semester's work will be on reading, assimilating, writing about, presenting, and discussing materials on issues related to research methods in Sociology. Therefore, regular and punctual attendance is expected of each student in this class. In fact, regular and punctual class attendance is expected of each student at SHSU (see http://www.shsu.edu/~vaf_www/aps/documents/800401_001.pdf). Student attendance will be recorded at the beginning of each class meeting. Students **must** come to class and participate. Students are expected to read all required assignments and actively discuss the readings during the class meetings for which they are assigned.

Three Exams (3 @ 50 points each)

There will be three in-class exams. Each exam will consist of multiple choice and true/false questions (and possibly fill-in-the-blank and/or short essay questions). Additional information on the exams will be provided during the first class meeting.

Eight In-Class Group Research/Writing Exercises (8 @ 10 points each)

Eight in-class group research/writing exercises will be administered throughout the semester. Students must be present during the class period to receive credit for the group research/writing exercise. Details on the in-class group research/writing exercises (including grading) will be provided during the first class meeting.

Group Project (20 points)

One group project will be assigned during the semester. The project will require students to come together and act as a unit. Details on the group assignment (including grading) will be provided during the first class meeting (and again, prior to the due-date).

NOTE: Students must participate in the group project to earn any points on this assignment, as well as a final grade for the course. Failure to participate will result in a course grade of zero (0). Additional grading criteria will be announced in class.

Religious Holy Days

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: “a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...” A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
