- Classroom Rules of Conduct: Students are expected to assist in maintaining a classroom environment that is conducive to learning. Students are to treat faculty and students with respect. Students are to turn off all cell phones while in the classroom. Under no circumstances are cell phones or any electronic devices to be used or seen during times of examination.
- Make-up exams will be given at my discretion depending on the related circumstances. You must notify me in advance of the exam which is missed. If you miss an exam due to illness you must have a documented medical excuse from the doctor or infirmary.

- Tests begin at the start of class and are over when the instructor says it's over. Once someone turns in their exam, you will not be allowed to take that exam (show up on time).
- Homework is due on the due date. No homework will be accepted late (no excuses). You are allowed one homework drop grade.
- Regular attendance is expected. After roll has been called, students are responsible for notifying the professor of their late arrival to avoid incurring an absence. Whether the tardiness is excused is at the discretion of the professor. The instructor retains the option to penalize excessive absences (4+) by a reduction in grade points. If you have four or more absences, your final average will be reduced by one percentage point for each absence over three, unless there are extenuating circumstances as determined by the instructor. A student who leaves prior to the end of class will be counted as absent, unless excused by the professor.
- No extra credit will be given.

Definition of Critical Thinking:

Critical Thinking is an ongoing process where beliefs and assumptions are continually assessed and revised in light of new evidence.
