Course description:

In this course you will learn how to identify good news stories, learn interviewing techniques, learn researching skills for supporting information and how to report the news with accuracy, precision and balance on a deadline. This course will cover the theory and practice of writing specialized stories typically covered by the news media. Emphasis will also be placed on knowledge of current events.

Required materials:

Tuggle, C.A. Broadcast News Handbook, Writing, Reporting and Producing in the Age of Social Media. 5th Edition. McGraw Hill, 2014.

Course Objectives:

You will develop your news reporting skills by:

- Writing Readers
- Writing VO/SOTS
- Writing Packages
- Researching
- Writing, Editing and Shooting VO/SOTs for Cable Channel 7
- Writing for Radio/Newspaper

Methods:

To keep up with the news you are expected to regularly:

- Watch Broadcast Network Nightly New, NBC, ABC, CBS, FOX
- Watch Area Local Broadcast News, (Houston News)
- Read the Houstonian and the Huntsville Item

We will frequently compare how each of these news organizations covers an issue or event.

Assignments:

Most of our focus will be on writing different types of news stories. These will be evaluated on two levels: 1) The reporting involved to get the story (the people you interviewed, as well as your thoroughness of your research and the angles you pursed) and 2) The actual writing (clarity, organization, focus, creativity, grammar and spelling). You are required to interview people face to face, taking extensive notes and later in semester on camera interviews. If there is any question about the authenticity of your story, you will be asked to provide phone numbers and email addresses of your subjects.

It is likely you will be assigned to cover events or conduct interviews off campus. You must provide your own transportation. All written assignments must be typed and in correct format.

Critiques

Students' work will at times be read, displayed or distributed to class. This is one way to learn what works well and what doesn't, by example. Critiques and comments are to be respectful and constructive.

Quizzes, Exercises and Tests

There will be weekly quizzes and graded exercises/or videos based on reading, assignments, and lectures.(60% of grade) There will be three tests over material discussed in class.(40% of Grade)

Late Work

In the News Industry there is no such thing as late work. All assignments must be turned in on time. Any and all assignments are due on the due date. After Class is late. If I say turn it in now, you turn it in at that time, not five minutes later. Five minutes later is LATE. Please do not ask me for ways to resolve your deadline problems. If you show up late for class and miss the start of a quiz or a test, you will not be able to take the test or quiz and will receive a ZERO(0) for its grade. Because you are late.

You will be working with a partner on some assignments, both will turn in their own work so each student will receive credit on what they did and grading will be separate.

Attendance:

Attendance will be taken at the start of each class. If you come in after attendance has been taken please remind me at the end of class. Students will be allowed **2** class days of absences without penalty. Any Additional Absence over 2 class days will result in a final grade reduction of one letter grade from the final letter grade.

Doctor's excuses will be accepted for an excused absence. The note must be on official letterhead from their office.

Academic Dishonesty:

All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. Any ideas or materials taken from another source must be fully acknowledged. If you reference someone else's work, give them full credit. Any student who plagiarizes will receive a failing grade on the assignment and is subject to an F in the course, disciplinary referral to the dean, even expulsion from this institution.

Writing Center:

You should already know proper grammar and mechanics, including the correct use of punctuation. If writing is difficult for you, I urge you to visit the Sam Houston Writing Center, located in Farrington 111. Tutors are available to work with you one-on-one at no charge. Computer Use:

The computers in this classroom are for schoolwork only. You are not allowed to do personal business on the computer (such as checking your email or Facebook page) during class. During class lectures and discussions, you are allowed to use the computers only to take notes or as directed to complete assignments. Students who violate this policy might be asked to leave.

Please dress professionally when conducting interviews or covering events. Some sources and members of the public will make a judgment your professional credibility based on your appearance.
