Course Description

Techniques of Research Proposal Writing in the Social Sciences is designed to provide students with a critical understanding of the principal theoretical aspects and technical skills necessary for the development of written research proposals in the social sciences. Through an examination of fundamental theories, research methods, and concepts in the social sciences, students will increase their understanding of various analytical techniques necessary for the preparation of "fundable" research proposals. This course is specifically designed for students who plan to engage in original research.

Course Objectives

Upon completion of this course, you will have developed the specific skills, competencies, and points of view needed by social scientists who write research proposals and engage in original research.

In addition, you will have increased your understanding of:

- the different theoretical perspectives used in research proposal writing.
- the numerous research methods used in research proposal writing.
- the various sociological concepts pertinent to social science research.

And furthermore, you will have:

- determined how to make your proposed project feasible.
- solved potential theoretical and methodological problems.
- provided yourself with a checklist of research activities to follow once your proposed research is underway.

Requirements and Grading

Readings and Weekly Assignments

(60% of final grade; 14 assignments totaling 145 points)

Students will be expected to read all required assignments and submit weekly assignments. Each weekly assignment will be posted under the "Assignment" tab. Information regarding due date, submission, grading criteria, and possible points will be posted with each assignment.

Research Proposal

(40% of final grade; 1 research proposal totaling 100 points)

The major written assignment will be the preparation of a professionally polished research proposal. Students may take a quantitative, qualitative, or a mixed-methods approach to their research design. Regardless of the approach, rigor is required. In order to fulfill most of the weekly assignments, students will be required to submit sections of their research proposal throughout the semester. The instructor will provide students with comments/feedback on each section. The final submission must be typed, double-spaced, and fully-referenced. The final submission should, in most instances, be between 25 and 35 pages in length (not including cover page, references, and appendices). All citations and references in the research proposal must adhere to ASA format guidelines. examination or complete an assignment from which the student is excused within a reasonable time after the absence.

A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s).
