<u>Course Description</u>: This course is a study of financial principles as applied to corporate investment and financing decisions. The ethical role of the financial manager is examined as it relates to value creation.

<u>Instructor Availability</u>: I am in my office during the stated office hours. If it is impossible to make my office hours, an appointment should be made ahead of time. Do not come to office hours and expect to be re-taught material covered in class. You are expected to make an attempt to understand the material outside of class before coming for assistance. I highly recommend that you email prior to coming to the office – *even during office hours*.

Attendance:

- 1. Attendance is required, and role will be taken each scheduled class period.
- Absence(s) of 6 hours or more will result in a final course grade of "F." <u>This includes absences on ALL exam dates</u>.
 For a section that meets twice per week, six hours of absence roughly equates to 4.5 class periods.
 For a section that meets once per week, six hours of absence roughly equates to 2.25 class periods.
- 3. **YOU** are responsible for tracking your own attendance. I will not give you a running tally.
- 4. - a. There will be 5 exams. Your numeric score for the course will be the average of your four highest test scores. Numeric scores for all students will be rank ordered and break-points for alphabetic grades will be assigned in a manner consistent with the ranking.

- c. Exams will be administered during normal class hours on the dates stated below. Students arriving late to class on days of an exam will not be allowed to take the test if they arrive after the first student has turned in the exam. In such an instance, a grade of zero will be recorded.
- d. If the absence does not meet both of these criteria, the exam grade will be zero.
