**Course Description:**

This course addresses the theoretical and sociological issues associated with family violence. Pertinent aspects of family violence to be explored include child abuse, sibling abuse, intimate partner violence, stalking, and elder abuse. In addition, the criminal justice response to family violence by law enforcement, judicial, and legislative agencies is examined.

### **Online Classroom Demeanor:**

Issues surrounding family violence involve many sensitive topics. Estimates of the prevalence of family violence suggest that the vast majority of college students have either directly experienced some form of family violence or have a close friend or family member who has been a victim of family violence. It is imperative that we are mindful of these facts in discussing topics across the semester. It is my policy that I will not allow any form of joking, sarcasm, or otherwise insensitive remarks about violence during this course. Students found to be in violation of this policy will be immediately dropped from the class.

As an online course, our discussions and conversations will take place through written communication. One main disadvantage of this mode of communication is that we cannot hear the tone of voice nor read facial expressions/body language. Therefore, it is crucial that we take our time and are deliberate in crafting any postings on the Discussion Board.

**\*Do not disclose that you or someone you know has been a victim of family violence.** While the content of this course certainly affects people (perhaps you or someone you know), this is an academic setting and it is important to distinguish between anecdotes and trends based on research.

In addition, some topics may be disturbing to students. ### **Course Objectives**

1. To gain *factual knowledge* (terminology, trends, and concepts) of the estimates of prevalence, severity, and types of family violence.
2. To have students *analyze and critically evaluate* the myths and facts regarding issues in family violence.
3. To learn to *apply course materials to improve thinking and problem solving* abilities regarding issues of family violence.

### **Course Requirements (See Class Schedule for Due Dates for all Required Work)**

#### **Exams: (20 Points Each = 80 Total Points):**

Each student is required to take four 20-point examinations, for a total of 80 points. These exams will consist of multiple choice and true/false questions. Questions will be composed of information from the textbook and lectures. The exams will be open book and will be timed for a *one-hour* time period. It is important that the student is prepared to take the exam before

opening the test. Experience shows that students who are not well prepared in advance will not do well on the timed tests. The exams are to be taken during the time allotted.

In the event of an *extenuating circumstance* and with *prior notice* to the Professor, students may make up **ONE** exam during the semester. All make-up exams will be given during the **week before finals week (Week 13: November 27 thru December 3)**.

**Writing Assignments: (5 Points Each = 20 Total Points):**

Each student is required to complete four writing assignments worth 5 points each. All writing assignment videos are located in the **Writing Assignment Videos** folder on the left hand side of the course on Blackboard under **Course Information**. These assignments can be completed at your discretion, but **MUST** be completed by the due date specified in the **Course Schedule**.

These assignments will require students to watch one or more videos and submit a 3 to 5 page paper describing their response to the video(s) in context of the assigned readings. Each assignment should be well-developed, show a strong understanding of the assigned reading material, and demonstrate correct grammar, spelling, punctuation, and sentence structure. Assignments should be a minimum of three FULL pages, **APA writing and citation style, double-spaced with Times New Roman, 12 pt. font**. Each Writing Assignment will be graded according to the grading rubric. The rubric can be found in the **Course Information** section on Blackboard.

Additionally:

- 1) Have a cover page with your name, course number, title of paper, and date. This **DOES NOT** count toward the 3-5 page limit.
- 2) Each paper should use 3 to 5 reference sources and they can be: the video, the textbook, and other sources.
- 3) Each paper will have a reference page which **DOES NOT** count toward the 3 to 5 page minimum.
- 4) 3 to 5 page minimum means written text. It cannot not be shorter than 3 full pages of written text or you will lose points.
- 5) Properly cite your work. If you have questions, ask me or my TA.

To submit your writing assignment via Blackboard, navigate to the Writing Assignment Videos link. Click on the "Writing Assignment 1" folder (or current assignment folder), and use the TURNITIN link provided to submit your assignment. Your assignments must be typed in Microsoft Word and uploaded to the TURNITIN link by attaching it and submitting it. **There are NO make-up opportunities for the writing assignments.**
