Course Description:

This course addresses the theoretical and sociological issues associated with violence against women. Specific attention given to intimate partner violence, rape and sexual assault, prostitution, pornography and media depictions of violence against women, campus and workplace violence. In addition, the criminal justice system and public health responses to violence against women will be examined.

Online Classroom Demeanor:

Issues surrounding violence against women involve many sensitive topics. Estimates of the prevalence of violence against women suggest that the vast majority of college students have either directly experienced some form of violence or have a close friend or family member who has been a victim of violence against women. It is imperative that we are mindful of these facts in discussing topics across the semester. It is my policy that I will not allow any form of joking, sarcasm, or otherwise insensitive remarks about violence during this course. Students found to be in violation of this policy will be immediately dropped from the class. As an online course, our discussions and conversations will take place through written communication. One main disadvantage of this mode of communication is that we cannot hear the tone of voice nor read facial expressions/body language. Therefore, it is crucial that we take our time and are deliberate in crafting any postings on the Discussion Board.

In addition, some topics may be disturbing to students. If a student experiences distress or discomfort during the semester they are encouraged to contact a counseling professional such as the SHSU Counseling Center 936-294-1720 (<http://www.shsu.edu/~counsel/>). Objectives of the Course:

1. To gain *factual knowledge* (terminology, trends, and concepts) of the estimates of prevalence, severity, and types of violence against women.
2. To have students *analyze and critically evaluate* the myths and facts regarding issues involving violence against women.
3. To learn to *apply course materials to improve thinking and problem solving* abilities regarding issues of family violence.

Course Requirements (See Class Schedule for Due Dates for all Required Work)

Exams: (4 at 15 Points Each = 60 Total Points):

Each student is required to take four 15-point examinations, for a total of 60 points. These exams will consist of multiple choice and true/false questions. Questions will be composed of information from the textbook. The exams are open book and timed for a *one-hour* time-period. It is important that students be prepared to take the exam before opening the test. Experience shows that students who are not well prepared in advance will not do well on the timed tests. The exams must be taken during the time allotted.

Make-Up Exam

In the event of an *extenuating circumstance* and with *prior notice* to the Professor, students may make up **ONE** exam during the semester. All make-up exams will be given during the week before finals week (Week 13: November 27 – December 3).

Video Writing Assignments: (3 at 5 Points Each = 15 Total Points):

Each student is required to complete three video writing assignments worth 5 points each. All writing assignment videos are located in the **Writing Assignment Videos** folder on the left hand side of the course on Blackboard under **Course Information**. These assignments can be completed at your discretion, but **MUST** be completed by the due date specified in the **Course Schedule**. These assignments will require students to watch one or more videos and submit a 2 to 3-page paper describing their response to the video(s) in context of the assigned readings. Each assignment should be well-developed, show a strong understanding of the assigned reading material, and demonstrate correct grammar, spelling, punctuation, and sentence structure. Assignments should be a **minimum of two FULL pages, APA writing and citation style, double-spaced with Times New Roman, 12 pt. font**. Each Writing Assignment will be graded according to the grading rubric. The rubric can be found in the **Course Information** section on Blackboard.

Additionally:

- 1) Have a cover page with your name, course number, title of paper, and date. This DOES NOT count toward the 2 to 3-page limit.
- 2) Each paper should use 3 reference sources and they can be: the video, the textbook, and 1 other source.
- 3) Each paper will have a reference page which DOES NOT count toward the 2 to 3-page minimum.
- 4) 2 to 3-page minimum means written text. It cannot not be shorter than 2 full pages of written text or you will lose points.
- 5) Properly cite your work. If you have questions, ask me or my TA, Sarah Steele.

To submit your writing assignment via Blackboard, navigate to the Writing Assignment Videos link. Click on the “Writing Assignment 1” folder (or current assignment folder), and use the TURNITIN link provided to submit your assignment. Your assignments must be typed in Microsoft Word and uploaded to the TURNITIN link by attaching it and submitting it. There will be NO make-up opportunities for late Writing Assignments.

Book Review/Term Paper:

Select a book from the 9 titles listed below. Most of these books can be rented or purchased at a reasonable cost through Amazon and similar sites. Write a 6 to 10-page term paper using a minimum of **6 academic resources** demonstrating: 1) your in-depth understanding of the issues in the book and 2) what they mean for developing programs or interventions to address the problem. The textbook and the selected book may serve as two of your resources. Papers should follow the organization of an academic paper: a cover page, an introduction, sub-headings, a conclusion and a bibliography. The paper should follow APA format in 12-point font and double spaced. For all other directions, follow the same writing rubric as for the video writing assignments which can be found in the **Course Information** section on Blackboard.

Send me the title of the book you have selected by October 15th.
