## **Course Description**

An examination of the evolution of police in modern society with a special emphasis given to the role of the police play in contemporary society. Current research examining the function of the police will be examined.

# **Course Objectives**

- 1) Understand how concepts and practices of law enforcement have evolved in the western tradition in the United States.
- 2) Place current issues and problems of law enforcement in their historical perspective.
- 3) Demonstrate an understanding of police administration, especially as it pertains to organization, management, and operations.
- 4) Demonstrate an understanding of Police behavior especially as related to ethical and legal perspectives.
- 5) Develop an understanding of modern police issues and demonstrate a working knowledge of one of these issues through written products.

## **Course Requirements**

PowerPoint Introduction (first two days of classes)

Each student will be required to post a 5 slide presentation about themselves. This is our way of introducing ourselves to each other in the class. Slide one should have your name and ideally a picture. Slide two should tell us a little about your background – where you are from. Slide 3 should tell us about your educational background. Slide 4 should tell us about your work background. And slide 5 should tell us about your personal life, something unique about you, hobby's, interests – anything you would like to share with the class.

Discussion Board: Monday 8 a.m. through Midnight Fridays

Each week you will be required to post to the discussion board, monitor the posts, and reply to the posts. The discussion board replaces classroom discussion, so you will need to participate. Discuss and debate the readings assigned for the week, sharing your perspectives and insights into the readings. Highlight issues you have, challenge the conclusions the authors draw from, and consider the research methodology as well. Discussion tangential to the readings is acceptable, only it must pertain to the overall topic being discussed. See the BB page for additional instructions.

Two Session Combined Papers due Saturdays by Midnight

Each week you will be required to write a 4-5 page paper detailing your analysis of the week's readings. The first page, up to 1 and ½ pages should be a review of the articles. Synthesize the key points made in all of the readings, do not try to review each chapter and each article one by one. After focusing your review of the week's readings, the rest of the paper should be your analysis of the readings. See the BB page for additional instructions.
