Course Description:

This course is for students with no previous knowledge of Arabic. At the end of this course, students will master the Arabic alphabet, learn how to read and write Arabic and will begin building up their vocabulary. They will be able to greet others, introduce oneself and others in a formal and informal ways, state where they and their family members live and come from. They will be able to count, invite, ask questions (Who, what, where, when, how), take leave, exchange phone numbers, express likes and dislikes describe people and things (in terms of colors, shapes, sizes and traits), apologize, order food and drink, and express feelings.

Objectives of the Course:

In Arabic 1411, students begin to acquire the essential Arabic that will allow them to function in the language in a variety of social and cultural contexts. Students learn the alphabet, acquire basic vocabulary, and basic conversation. By the end of the semester students should be able to

- 1. Listen and understand basic conversation about lives of others.
- 2. Speak in a few sentences about oneself.
- 3. Read basic Arabic sentences.

4. Write any word or sentence heard in Arabic and should be able to write a few sentences talking about oneself.

Exams:

There will be a test after we finish each 2 chapters from *Alif Baa*. Each exam will include a dictation, vocab, and oral part, and will be closely related to material covered in the textbooks and in class.

Attendance Policy:

Presence is mandatory. **Three hours** of absence (whether justified or not) are permitted. After 3 hours of absence, each subsequent hour will deduct **One Point** from the semester final grade. Please note that this policy reflects the policy of the Foreign Language Department at SHSU.
