- Academic Honesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. - **Classroom Rules of Conduct:** Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins. Students are prohibited from eating in class, using tobacco products, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.
- **Cell Phone Policy:** Sam Houston State University policy prohibits the use of cell phones or similar devices capable of sending and receiving voice or text communications in the classroom. All such devices must be put away and out of sight when the student enters the classroom. Failure to comply with this policy could result in expulsion from the classroom or with multiple offenses, failure of the course. Further, the use of a telephone or text messaging device is strictly prohibited during the taking of quizzes and tests. The visible presence of such a device during a quiz or test will result in an automatic zero for the test.
- **Visitors in the Classroom:** Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered

student, it is at the instructor's discretion whether the visitor will be allowed to remain in the classroom.
