English 3330, Introduction to Technical Writing, is required by 18 majors and strongly suggested by more than 20 here at Sam Houston State University. That's strong evidence that a significant number of decision makers consider Tech Writing important. Of course, you want to know, "What is it?" Good question. Tech Writing is a scary title. Suggests writing complex formulae for interplanetary travel and detailed contracts for international trade and expansive manuals for open heart surgery. Those topics are legitimate subjects for Tech Writing, but this course actually deals with the kind of writing you will do day-to-day. Over this semester, we'll write basic business letters, proposals, instructions. Because many of you are Criminal Justice majors, we'll write a proper criminal complaint, the document which leads to an arrest warrant. Because each of you wants to begin a successful career, we'll crate a job portfolio. Because the ability to find facts, assemble facts, interpret facts is absolutely necessary regardless of your endeavor, we'll generate a comprehensive e research project.

That's not to say that all we'll do is write papers and turn them in for grading. Speaking is as important as writing. It's quite common for your supervisor to ask for a 30-second summary of the 300-page analysis you've put together over the past two years. You'd better deliver. Remember, time is money and your supervisor makes the most money and, therefore, his time is the most valuable. Don't waste it. Tell him what he needs to know. Don't panic, you'll get plenty of experience in oral presentation both planned and impromptu.

To my way of thinking, Eng 3330 is practical writing. Every skill we practice in this course you can take right outside and use. A proper business letter? You'll sue them daily. A complaint? You need to understand how the Criminal Justice System works. Job portfolio? If you didn't want a good job, you wouldn't be here.

There are, of course, some personal requirements for my classes. First, I expect you to behave as a lady or gentleman of the highest standard. Informal dress is the style of the day and, even though we have gone too far with informality, I'll accept it. To a point.

Pajamas will not be allowed in my class.

Warmups will not be allowed in my class.

Flip-flops are not proper university footwear.

Gentlemen do not wear hats indoors.

I will decide if a particular item of clothing is or is not acceptable for my class.

Cell phones are not be used during my class unless I give specific permission to do so. An electrical device used improperly during a class exercise will result in a zero for that exercise.

Plagiarism will not be tolerated. Plagiarism is in fact theft. Thieves do not belong in this university.

#### **Classroom Policies**

Individual and group responsibility\_During the semester, students will perform in teams to read and constructively criticize members' written work and at times resolve a problem, such as presenting an oral presentation dealing with a specific challenge. Because each student's input is essential to the team, participation is required. Failure to perform as part of the collaborative team will show that a student lacks the proper background to complete university assignments. Such a student will receive an F for the course.

Assignments Properly completed assignments ae due on the due date. Late assignments have no place in Tech Writing and will not be accepted.

The instructor may require that work be submitted to a plagiarism detecting service such as turnitin.com.

Enrolling in Engl 3330 and electing to stay in the section assigned constitutes a student's agreement to submit work as the instructor requires.

Ce*ll phones and electronics* The use (including visible presence) of cell phones, text messengers, and all similar electronic devices is prohibited during class-time. Failure to comply with this policy can result in expulsion from the classroom. Failure to comply with this policy can result in an absence recorded on the guilty student's grade sheet.

Even the visible presence of an electronic device during a test will result in a zero for that test and, at the instructor's discretion, can result in an F for the course.

All electronic devices should be turned off or put in a silent mode during class.

To be clear, students are prohibited from checking e-mail, checking time on cell phone, leaving the classroom to answer a cell phone call, surfing the net, or engaging in any activity involving an electronic device. Electronic devices can be used during class only with specific permission from the instructor. Penalties for using electronic devices without specific permission from the instructor are:

an absence being registered for that day a zero being recorded for the current assignment

NOTE: These rules apply whether class is held in the classroom, another location, or the class is on a field trip.

**Visitors in the Classroom** Unannounced visitors to class must present a current, official SHSU identification card to be permitted into the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom. This policy is not intended to discourage the occasional visiting of classes by responsible persons. Obviously, however, the visiting of a particular class should be occasional and not regular, and it should in no way constitute interference with registered members of the class or the educational process.

**Instructor Evaluations** Students will be asked to complete a course/instructor evaluation form toward the end of the semester.

Should an emergency arise (such as a serious illness or death in the family) students should report unavoidable absences through the Dean of Students. The Dean of Students will assist in gathering required documentation and informing all professors of the circumstances. The instructor will decide whether the documented circumstances qualify as an excused absence or not.

If unable to attend a class, students must be prepared when returning. Much of what a student needs to be prepared will be on the calendar in this syllabus, but the calendar may change. After an absence, each student is responsible for preparing himself before returning to class. An absence does not excuse a student for lack of preparation.
