Syllabus for Seminar

Description:

This seminar is a wide-ranging course that will broadly cover the subject of secondary compounds in plants used for drug purposes. In particular the class will cover the three main categories of recreational/mind altering: Hallucinogens, Stimulants, and Depressants. We will discuss the effects of drugs on culture, economies, religions, and health. Many formats will be used, including lecture, films, readings, and written assignments.

The Doors of Perception. By Aldous Huxley

Schedule: Section 1

Dr. Williams Unit: Hallucinogenic Plants.

Dr. Williams will lecture on the various species of plants from which Hallucinogenic drugs are derived. The class will then read two different accounts of an individual's experience while hallucinating on Peyote: Aldous Huxley and Carlos Castenada. This section will also discuss some of the religious and metaphysical aspects of various drug cultures.

Academic Dishonesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. Students who are especially disruptive may be reported to the Dean of Students for disciplinary action in accordance with university policy.

Visitors in the Classroom: Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.

Religious Holidays: Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of

a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
