**Course Description.** This course examines Texas government and politics, including political culture; the Texas Constitution; Texas' role in the federal system; individuals' political values and participation; interest groups, parties, elections and campaigns; the legislative, executive, and judicial branches; and fiscal, social, and economic policies. Credit 3.

Course Objectives. Specific course objectives include...

- 1. Explaining the origin and development of the Texas constitution.
- 2. Describing state and local political systems and their relationship with the federal government.
- 3. Describing separate of powers and checks and balances in both theory and practice in Texas.
- 4. Demonstrating knowledge of the legislative, executive, and judicial branches of Texas government.
- 5. Evaluating the role of public opinion, interest groups, and political parties in Texas.
- 6. Analyzing the state and local election process.
- 7. Identifying the rights and responsibilities of citizens.
- 8. Analyzing issues, policies, and political culture of Texas.
