## CRIJ 4338.03 (On-Line) Child Abuse and Neglect FALL 2017

**Course Description:** This course addresses key issues related to child abuse and neglect. It examines: the history of child maltreatment; definitional challenges; statistical trends; physical and behavioral indicators; mandatory reporting; investigative processes; intervention strategies; and prevention efforts.

Course Objectives: By the end of the course, students will have:

- gained factual knowledge (terminology, classifications, methods, trends);
- learned to apply course material (to improve problem solving and decision-making); and
- developed specific competencies needed by professionals in the field.
