This course is offered to graduate keyboard majors. The student earns one semester credit hour. In this course, a complex vocal and instrumental accompanying repertoire is surveyed, prepared and coached by the instructor of this course.

### LEARNING OBJECTIVES

The purpose of this course is to ensure that students have the opportunity to further develop their skills and knowledge of the piano accompanying repertoire, as well as improvisation, sight reading, transposition and clef reading skills. The repertoire studied will enable them to deal confidently in the professional piano accompanying music world.

### EXPECTED STUDENT OUTCOMES

- Develop collaborative skills and the sense of teamwork
- Demonstrate an understanding of different accompanying styles with different instruments through supervised classroom instruction
- The student will set short term and long term performance goals
- Enhance and accelarate the score learning process
- Improve improvisational skills

- All students are committed to play for one student degree recital. Repertoire will be distributed on September 5th, 2017.
- Study the music of your entire ensemble (not just your part).
