COURSE DESCRIPTION:

This is the required survey course in Texas government. The course provides a broad look at the political and institutional foundations of Texas government. It begins with an overview of Texas constitutions, dominant political culture, and the workings of federalism. The Texas legislature, Governor, and dual court system are presented next. These are followed by political parties, interest groups, and elections in Texas. Finally key policy areas are examined, including education, immigration, and the environment.

Approach/Method of Instruction: Classes are devoted to lectures and discussion. Lectures will be used to elaborate on or amplify material in the text, highlight topics or themes that may or may not be covered in the text – and provide optimum time and opportunity for discussion of any and all relevant topics and issues.

Prerequisite: None

COURSE OBJECTIVES:

- Factual Knowledge: the "nuts and bolts" of the Texas political and governmental systems, but in
 more precise terms, who exercises power in Texas, how, and on whose behalf. More specifically
 students should gain factual and analytical knowledge of Texas governmental institutions,
 political behavior, civic engagement, and their political and philosophical foundations; also to
 gain knowledge of civic responsibility and gain the ability to engage in democracy in Texas.
- Critical Thinking: learning to understand and evaluate the Texas political system in a more informed and "critical" manner: eschewing platitudes, hype, and knee-jerk opinions masquerading as "common sense."

REQUIRED TEXT:

Brown, et al, Practicing Texas Politics, 2017-2018 edition Cengage, 2018

Other reading may be assigned (or recommended). We will also make use of text online resources. Students are expected to keep up with current events: free copies of the Houston Chronicle are provided in various locations on campus.

ATTENDANCE POLICY:

Class attendance is required, following university regulations. Repeated absences result in a grade penalty. Makeup exams are given only for verified and excused absences and at the convenience of the instructor.

EXAMS:

There will be four exams, objective in format. Each of the exams count equally toward the final grade. (The final is not cumulative). Dates of exams will be announced in class.

GRADING PLAN:

Grades will be based on the exams. The normal grading scale is used: 90 and above, A; 80 - 89, B; 70 - 79, C; 60 - 69, D; and 59 and below, F.
