Course Description

The purpose of this course is to provide students with an introductory understanding of substantive criminal law, which includes definitions of law, definitions of crime, general principles of criminal responsibility, elements of major crimes, punishments and conditions of circumstances, which may excuse someone from criminal responsibility or mitigate punishment. Students will acquire a thorough and comprehensive understanding of the criminal law and will be encouraged to share viewpoints, opinions, and ask questions when discussing topics on the class discussion board.

Course Objectives

The primary objectives of this course are to:

- 1. Acquaint the student with the basic principles that underlie the American system of law.
- 2. Introduce the student to the laws, procedures, and policies involved in the criminal law process.
- 3. Acquaint the student with defenses and other mitigation of criminal responsibility and/or punishment.
- 4. Give the student a general knowledge on crime, victims, defenses, laws and sentencing.

ATTENDANCE & CLASS PARTICIPATON:

Class attendance requirements will be followed in accordance with Academic Policy Statement 800401. It is expected that students will attend EACH class session, complete reading assignments, complete discussion participate in-group exercises, and contribute to class discussions. Participation in online discussions is especially important in this class. Throughout the course of the semester, a student is allowed a maximum of one (1) unexcused absence (three hours). Students missing more than one class session will subject to having their final grade lowered one full letter grade for each unexcused absence, this will be pursuant to the instructor's discretion on student's full semester attendance record.

Course Requirements:

All students are expected to read the required reading assignments and participate in the online discussions for each course session. Since a substantial portion of this course will entail online discussion, it is especially important that students pay close attention to the readings to promote insightful interactions within the discussion forums.

- 1. Exams there will be three (3) exams.
- 2. There will be discussion questions. In addition to commenting on each question, you are required to comment on at least two (2) classmates' comments.
- 3. There will be numerous opportunities for extra credit.

Discussion Questions

Online forum discussions are a key component of the course. This is where most of the "activity" will take place. Students are expected to participate in each of the discussions for the course sessions. Generally, students will be required to contribute their own original post to the discussion, but will also be required to respond to the posts of two (2) other students. Participating in both of these functions is imperative to creating quality discussions. Additional details about the online discussions will be available on the course website.

CLASS BEHAVIOR:

Some of the substance of this course is likely to be controversial in nature. When asked to articulate moral or ethical thoughts on various matters, people often present a dogmatic or ideological position akin to a religious belief system. At times, our discussions will force us to examine ideas that are repugnant to such belief systems. In the best scenario, we will do so with an open mind welcoming the opportunity to set one belief system beside another gaining insight from the comparative perspective. In the worst scenario, we will become defenders of our beliefs and/or enemies of alternative belief systems.

Students in this class will be challenged to welcome and embrace diversity of opinion. Personal attacks against another person's belief system will not be tolerated. They will be identified as such by the professor (or any other class participant who senses that discussions have moved to a personal level) and stopped. Students who continue to engage in personal level challenges will first be counseled by the professor; but may ultimately be dropped from the class.
