COURSE DESCRIPTION

Catalog: Drawing from the model in various media. Gesture drawing and figure structure are studied. Line, Value, and Shape, Plane and Volume are used as elements to depict the figure in space with accurate proportions. The study leads toward a final portfolio that demonstrates proficiency representing the figure in cohesive and complete compositions. Prerequisite: ARTS 1316.

Drawing from the nude model. This is a further development of the drawing experience and introduction to human form in terms of edge, volume and mass. Anatomy, bone and muscle vocabulary will be introduced.

COURSE OBJECTIVES

1. Observation of human form in space. Specifically, seeing the volume and mass of that form.
2. Learn to look. The drawing exercises, done properly, will develop seeing the object being drawn. Developing this specific skill as it relates to artists and this course is an essential goal.
3. Drawing in gesture and contour, both with different results. One, gesture, is seeing the character of form – is it old, young, taut, loose, etc. The other is seeing the defined and detailed edge of an object, developing likeness.
4. Drawing using value, the likeness of a specific surface in relationship to specific lighting, revealing 3 dimensional substance/form.

ATTENDANCE POLICY

Attendance is required. Three absences only are allowed for the semester. If you know you'll be missing let me know. If a specific in-class exercise would be missed, I will give you instruction for completing the missed work. (Absences may require producing make-up drawings, either in the department's sponsored model sessions or in the students own model arrangements. A single page of multiple gestures and a single page of a more developed drawing would satisfy the requirement.) A 4th absence will lower the in-class drawing grade one full grade. A 5th absence will result in an F for the course.

GRADING POLICY

Grading plan:

1. In-class work 64%
2. Sketchbook 25%
3. Midterm and Final exam – students will draw from the model 6% [Midterm (2%) and Final (4%)]
4. Preparation 5%

The BFA standard is used to determine grades in A to F range, numerically that is a 4, 3, 2, 1, and 0 scale.

Assignments:

There will be daily drawing to do in class and drawings to do outside of class in a sketchbook. The sketchbook has requirements due weekly throughout the semester. All sketchbook drawings are required, if any go un-submitted, the course requirements aren't met and the course grade is an F. A list of sketchbook requirements titled "Sketchbook Schedule" will be posted on Blackboard.

A requirement for all work submitted for grade is to have your name and date on the back of the work. If they are missing the work will be graded as unfinished.

The **In-class work grade** is calculated from grades assigned to drawings submitted at semester's end, April 27th. The **submitted drawings** will be selected by the student and will consist of 5 pages of gestures and 10 pages of developed drawings. The **In-class work grade** will be determined using the following percentages – 20% for gesture, 80% for longer pose. These grades are impacted by the observation of the level and development of drawing shown by the student, comparing earlier drawing to later drawing.

The **sketchbook drawings** are required to be done weekly throughout the semester, submitted when due, each Tuesday, and then graded. The drawings are completed in the sketchbook and then removed and turned in. The required sketchbook allows for uniformity and for the drawings to be returned to the wire binding. Each time drawings are required a grade will be given and those grades averaged for the sketchbook grade.

The **midterm** is 2% of the course grade and allows the student to experience the process used for the final.

The **final** is 4% of the course grade. The final is scheduled in class for 2 days at the end of the semester, November 27th and 29th. Missing any one of these 3 dates – midterm or finals, will produce a 0 for that date. There will be no make-up option. However, if any 2 in combination or all 3 are missed the result will be an F for the course.

A **preparation grade** is given during the semester 5 times. Each of these 5 times there is a requirement connected to mandatory participation. The grading is simple, if you are prepared then the grade is A for that event, if you are not, the grade is F. There are 2 times when it is mandatory to have supplies. Both days you will need to be prepared in order to get the A preparation grade. If you aren't fully prepared for just 1 then that grade is F. This grade is 1% of the course grade. There are 2 days when we do a full class crit, you will be responsible for submitting finished work and to participate in the crit, discussing other students work. With the full participation this participation grade is A, and is 1% of the course grade. There are 2 days when we do specific exercises that will require full participation in group-projects. An A grade is earned if you participate both days. This grade is 1% of the course grade. Submitting finished in-class drawings at the end of class, November 20, will earn 1% of the course grade of A. The sketchbook assignments produce the last participation grade. If every assignment was submitted on time, then an A will be given for 1% of the course grade. The preparation grade when totaled is 5% of the course grade.

Unfinished work is at best a D grade. If 10 sketchbook drawings are required, and the student submits fewer than 10, that will be considered an unfinished assignment. The in-class work grade is affected the same way, if anything less than either the 5 gestures or 10 long poses is submitted, the grade for that will at best be a D. And all late work will receive a full grade reduction.

The Art students must pass a BFA review and maintain a 3.0 gpa. In that context, all grades in this course will reflect that standard. A B grade will indicate the work is appropriate for a BFA level student. An A will be reserved for exceptional work. And a C or lower will be given to work not acceptable for the BFA level.

Course grades. There are 2 factors that determine your grade.

1. Calculating the total from the 4 areas of above grading plan.

2. Apply Attendance policy to this and if needed lower grade.

MAKE-UP POLICY

Each week a sketchbook assignment is due at the beginning of class, on a Monday. It will be late if it is submitted after the first gesture drawing is started. (If the student is unable to attend class, and the work is completed, digital images of the drawings can be sent to me by e-mail [the due date and time is the same as that for students attending class]). I will accept them with no penalty, but when the next time the student is in attendance, the required drawings must be presented, in order to be graded.

The final sketchbook grade will be lowered 0.2 pts each time an assignment is late.

For **sketchbook work** see Assignments for effect on course grade if an assignment isn't turned in at all.

Example: if something, required to be turned in, comes in late and unfinished, the grade earned would be the D grade minus a full letter grade.

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY (ACADEMIC POLICY 3 861001)

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed. VISITORS IN THE CLASSROOM

Classroom Rules Of Conduct. Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. The following are listed as violations of these rules of conduct in Section 5 of the Student handbook. Unless faculty permission is obtained first, these are considered violations in this course. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

DEPARTMENT OF ART BFA REVIEW

The purpose of the BFA Review is to ensure that students have learned basic principles and techniques needed for advanced art courses.

All Art students must successfully complete all of the Art Foundation courses and the BFA Review before being accepted into a BFA program in Computer Animation, Photography, or Studio Art or Graphic Design. Graphic Design students must also pass a separate Graphic Design Review after the BFA Review.

The Art Foundation Courses are WASH, Drawing, and Foundations in Digital Art. (ARTS 1313, 1314, 1315, 1316, & 2313). Students must pass each course with a grade of C or higher to take the BFA Review and proceed to upper level courses.

The semester after all of the Foundation courses are complete, students must sign up for the BFA Review. Students should see an art advisor every semester to ensure they take the BFA Review on time. It should be taken the semester immediately following the completion of the Foundation Courses.

Students who do not pass the BFA Review may re-take it the following semester. Students who do not pass on the second attempt will not be allowed to continue as BFA majors, but may follow the degree plan for the BA in Art. Non-participation after signing up or being advised to sign up will count as a failure of that semester's review.

Graphic Design students must pass the BFA Review, complete Principles of Graphic Design (ARTS 2323) and participate in a BFA Review at the end of the semester that they are enrolled in Typography (ARTS 3322).
