Course description

This course aims to educate you with the methodology of questioned document examinations. The most utilized techniques by questioned document examiners are discussed in this class. This course covers the study of handwriting and signatures, the problem of recognizing their possible non-genuineness, the detection of forgeries, and the analysis of inks and printed documents.

Course objectives

After successful completion of this course you will:

- 1. Successfully acquire theoretical knowledge about the techniques and approach used in questioned document examinations;
- 2. Clearly understand the methodology for the examination of handwriting and signatures;
- 3. Appreciate the difficulties related to the subjective decision making process for handwriting examination.
- 4. Be strongly familiarized with the techniques for ink analysis currently used in forensic laboratories.

Attendance policy

Attendance will be recorded in keeping with University policy. Students are expected to attend class.
