#### COURSE DESCRIPTION

A study of the basic and more advanced techniques of instrumentation including ranges, transpositions, characteristics of band and orchestral instruments, as well as an array of effective traditional orchestration techniques. Practical application in the form of projects for various instrumental combinations.

#### **COURSE OBJECTIVES**

After successfully completing this course, students will be well-versed in the whole spectrum of instruments common to band and orchestral literature. Students will be able to independently and critically approach scores for study or ensemble preparation. Students will also gain experience orchestrating for instrumental forces, transcribing from solo piano to small chamber and large ensemble mediums, and properly preparing score and parts, as well as learning to analyze and create chamber music and ensemble music scores using a variety of techniques beyond those covered in MUSI 3362 Orchestration and Analysis.

## **CLASSROOM ETIQUETTE**

When you come to class, be prepared to participate in discussions and other activities involving the assigned readings, exercises, etc. Bring your questions to class. Students who have not brought their materials, are sleeping in class, are not paying attention, or are disrupting the learning environment in any way may be asked to leave and will be counted absent.

## **NEATNESS**

All work done for this class must be legible as determined by the instructor. Any work the instructor considers to be illegible will not be graded and will not receive credit.

### HOMEWORK POLICY FOR ADVANCED ORCHESTRATION

Any assigned work is due at the beginning of class without exception. If you are absent, you may get someone to turn your homework in for you at the beginning of class. No homework is accepted late. If you are late to class, you will not be allowed to turn in your work for that day.

#### DEPARMENT ATTENDANCE AND TARDY POLICIES

Regular and punctual attendance is expected of you throughout the semester. University policy permits three classroom hours of unexcused absence without penalty per semester (TTH = 2 absences). Reserve these for possible emergency or illness. For each additional unexcused absence, three points will be deducted from your final grade percentage. Valid excuses include official university functions or illness with appropriate documentation. If you anticipate a legitimate absence on a quiz or test date, contact your instructor in advance so that a make-up test can be scheduled. Once a quiz or test has been returned, a make-up quiz test will not be possible. You are responsible for all assignments and material covered on the days of your absence.

The instructor will take attendance at the beginning of each class period. Students not arriving by the time roll is completed will be counted absent. It is the student's responsibility to make sure the instructor changes the record in Blackboard from absent to tardy. Every student will be allowed 2 tardies without penalty per semester. Every third tardy will be counted as equal to one absence. (3 tardies = 1 absence, 6 tardies = 2 absences, etc.) Thus, attendance and punctuality are a significant factor in determining your final grade in this course.

### PREREQUISITE SKILLS

MUSI 3372 will require students to enter with a basic understanding of different musical instruments from the orchestra and band ensembles along with some basic concepts used to write effectively for these instruments such as basic bowing approaches, transpositions, etc. Students without experience in these areas will receive access to information to help them, although a limited amount of time may be spent on fundamentals. This course will require students to complete assignments/projects using music notation software. While laboratory instruction for *Finale*® may be given during class, a basic understanding of computer-based skills and notation software is required of students to successfully achieve these tasks.

# STUDENT ABSENCES ON RELIGIOUS HOLIDAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose.
