**Description** Study of instrumental skills as applied in the music therapy setting utilizing guitar,

keyboard, percussion, autoharp, ukulele, and other instruments. Designing music therapy interventions for utilizing various instruments and ensemble strictures will be included.

**Prerequisites** Music therapy majors only.

**Course Objectives** 1. To acquire clinical musicianship on a variety of instruments as appropriate for multiple

music therapy populations and applications.

2. To develop facility in adapting instruments to meet the needs of a variety of music

therapy clients and populations.

3. To gain competence in song leading, accompaniment, and clinical music leadership as

appropriate to the music therapy setting.

This course addresses a variety of American Music Therapy Association Professional Competencies including, but not limited to:

- 2.2 Adapt, arrange, transpose, and simplify music compositions for small vocal and nonsymphonic instrumental ensembles.
- 4.1 Demonstrate a basic foundation on voice, piano, guitar, and percussion.
- 4.1.1 Lead and accompany proficiently on instruments including, but not limited to, voice, piano, guitar, and percussion.
- 4.1.2 Play basic chord progressions in several major and minor keys with varied accompaniment patterns.
- 4.1.3 Play and sing a basic repertoire of traditional, folk, and popular songs with and without printed music.
- 4.1.4 Sing in tune with a pleasing quality and adequate volume both with accompaniment and a capella.
- 4.1.5 Sight-read simple compositions and song accompaniments.

- 4.1.7 Tune stringed instruments using standard and other tunings.
- 4.1.8 Utilize basic percussion techniques on several standard and ethnic instruments.

## Instructional Methodology

Experiential course with interactive class discussions, demonstrations, presentations, and role play. Students demonstrate mastery of course objectives through in-class competency assessments.

### **Course Policies**

Students who accrue an unexcused absence on a day they are scheduled for an inclass competency assessment will not be allowed to make up the assessment and will receive "0" points.

Absences must be documented prior to class (when feasible) by means of a phone call to the instructor's office. Leave a message on voice mail, if necessary. Please understand that this documentation does not by any means guarantee an excused absence, but without such notification AND a valid, documented excuse (e.g., written doctor's notice, funeral notice) all absences will be considered unexcused. If your absence is due to a serious illness, hospitalization, death or serious illness of a close family member, please contact the Dean of Students to coordinate communication to faculty regarding your possible extended absence.

It is the student's responsibility to provide appropriate documentation regarding an excused absence and the professor will not reach out to students for such documentation. Simply telling the professor that you will not be in class, or telling the professor afterward why you were not in class, is not adequate documentation for an excused absence.

**Final Exam:** Students will complete an in-class final exam that involves developing and implementing a written intervention plan for a group intervention utilizing a variety of instruments covered during the semester.

**Music Therapy Technology Review:** Students will research an assigned technology that can be utilized and/or adapted for use in music therapy settings and present a brief report of potential therapeutic applications.

**Guest Artist Lecture Attendance:** Bill Matney, PhD, MT-BC is our guest artist this semester. All music therapy students are required to attend his scheduled events as designated on the attached calendar.
