<u>**Course Description**</u>: This course will focus on specific stage combat disciplines with compulsory techniques. Students will be exposed to unarmed combat, rapier and dagger, and other forms of violence found on stage and film. Each stage combat technique will be taught for safety, theatrical commitment and believability within a dramatic context. Credit 3 hours.

<u>**Course Objective:**</u> Effectively use the body in hand to hand combat techniques. Employ a variety of conditioning and centering exercises as they relate to the discipline. Master the skills identified as the basics of unarmed stage combat by the Society of American Fight Directors. Master the skills identified as the basics of rapier and dagger combat by the Society of American Fight Directors(SAFD). Competently tell a story on stage through the use of stage violence.

<u>**Classroom Attire:**</u> Please wear comfortable, non-restrictive clothing, preferably dance or yoga attire. Form fitting is always better. We will be bending and stretching in all directions. Skirts and jeans are a bad idea. Footwear: MUST BE CLOSED TOE W/TRACTION. Students without proper footwear will not be allowed to participate in class. Please remove all jewelry. Keep hair pulled back off of your face. A water bottle is always smart. Please eat before class, but NOT DURING. No food please.

<u>Classroom Demeanor</u>: This is NOT a lecture class. We learn by doing. Come to class focused and ready to move, interact, discuss and perform. You will be asked to work alone as well as with others. NO CELL PHONES, TABLETS, OR COMPUTERS IN CLASS. If you are caught texting or the like in class, your grade will be reduced. Please don't. No Classroom Visitors.

If a cellphone rings, dings, etc. during class, EVERYONE does 20 push-ups. SILENCE YOUR PHONES! If my phone goes off, I do 20 push-ups.

The classroom is a space in which many ideas and opinions are expressed and discussed. I ask that all students show respect, sensitivity, and discretion with each other and the topics that may be discussed in the classroom.

<u>Required Reading:</u> No Textbook required.

<u>Required Supplies:</u> One pair of leather gloves. Gauntlets are best but expensive, batting gloves/work gloves are perfectly acceptable.

Attendance Policy: The only way to learn is to be present and active in class. I do take roll. Everyone gets one free absence. Use it wisely. Three unexcused absences will result in the lowering of your final grade by an entire letter (i.e., A will become B, etc.) Six or more absences will be an automatic F. Tardiness is unacceptable. If you are tardy three times, that equals one absence. Excessive tardiness will result in a reduction of your final grade.

Participation (100 pts): The only way to learn is to be present and active in class. I do take roll and attendance/class participation are parts of your final grade. However showing up won't cut it. You will need to take an active role in the class execerises, dicussions, and be a generous classmate. (4 pts per class)

Unarmed Skills (200pts): You will be asked to demonstrate proper technique for Unarmed combat as taught by the SAFD. Proper technique will include terms, footwork, audience perspective, and safety. Details of the assignment will be given.

Rapier Skills (200pts): You will be asked to demonstrate proper technique for Single Sword/Rapier &Dagger combat as taught by the SAFD. Proper technique will include terms, footwork, audience perspective, and safety. Details of the assignment will be given.

Unarmed Scene (200pts Total, 150pts Scene & 50pts Choreography): You will partner up with a classmate of your choice and together you will select a scene from a theatre that

contains unarmed violence. After your scene is approved, you will work with your classmate on the scene both inside and outside of the classroom. You will work with your instructor to apply choreography taught by instructor to scene. You will present the scene memorized, rehearsed, and staged for the class. You will also turn in written choreography. Details of the assignment will be given.

Unarmed Scene (300pts Total, 250pts Scene & 50pts Choreography): You will partner up with a classmate of your choice and together you will select a scene from a theatre that contains violence. After your scene is approved, you will work with your classmate on the scene both inside and outside of the classroom. You will work with your instructor to apply choreography taught by instructor to scene. You will present the scene memorized, rehearsed, and staged for the class. There will be a performance date with outside members of the class (faculty, staff, students) who will observe the final scenes. You will also turn in written choreography. Details of the assignment will be given.

A Note about Scene Work

Much of your grade will be based on partner work. You must be available to work with a partner in the rehearsal process, both in the classroom and outside the classroom. If you are unavailable to work with your partner, your grade will be lowered. Please make an effort to meet and rehearse your scene. You will be thankful you did. If <u>you</u> do not show up on the day when your scene is due to go up, <u>you</u> will be given an automatic ZERO for your scene. Your partner will not be penalized. Scenes are presented to the class and then reworked. Your grade is based on both the initial and the reworked performance.

If the student is unable to complete course requirements, the student's grade will reflect this.
