**3. Course Description:** Topics may include sets, counting principles, probability, number systems, geometry, and number theory and graph theory.

Prerequisites: Two years of high school algebra and high school geometry.

The class will be lecture-oriented.

- **4.** Course Objectives: You will learn to analyze, logically address, and solve problems.
- 5. Required Textbook: Mathematics-A Practical Odyssey by Johson and Mowry, Eighth Edition.
- **6. Required Supplies:** A scientific calculator that includes the trigonometric functions as well as permutation and combination keys is required. I recommend either TI-83 or TI-84. Calculators are allowed on exams and you will be at a disadvantage in exams without a calculator.
- **7. Attendance Policy:** You are expected to attend every class and to arrive on time. If class must be missed, you are expected to get the notes and homework assignment from a classmate.

## 8. Homework Assignments:

Homework will be assigned every class period. Please solve homework problems, show all work and write your solutions neatly in a College-ruled spiral notebook. Clearly write your name and student ID on the cover or the first page of the notebook. These notebooks will be collected during each of the four exam dates. The notebooks will be looked at for completion and serious efforts to solve the homework problems. Each satisfactory notebook will earn you 2.5% for a total of 10% for the homework portion of the class.

**9. Exams:** There will be three exams during the semester and then a final exam. The exams are scheduled to occur on:

Exam 1: Monday, September 25<sup>th</sup> Covers Chapter 2 and Sections 3.2 through 3.4

Exam 2: Monday, October 23<sup>rd</sup> Covers Sections 3.5 through 3.7 and Chapter 7

Exam 3: Monday, November 20<sup>th</sup> Covers Chapter 8

Any changes to this schedule will be announced in class.

There are no make-up exams. If you miss an exam because of an emergency, then contact me immediately. With my approval, the percentage on the final exam can replace the missed exam.

The final exam will be held on Monday, December 4, 2017 from 8:30pm to 10:30pm. It will be comprehensive, unless otherwise noticed.

The course grade will be assigned using:
