COURSE DESCRIPTION

This is an introductory course designed to familiarize you with the facets of the criminal justice system, the sub-systems and how they interrelate, processing of offenders, punishment and its alternatives, and the future of the criminal justice system. This class will make extensive use of Blackboard to facilitate learning and communication. Lecture materials and links to resources will be posted on the class site. You are expected to take personal initiative in self-assessing your understanding of course material by taking learning checks that are available on the class site. In addition, discussion assignments will be given across the semester that will require you to read and post material to the discussion board.

There will be a quiz with each assigned chapter. The quiz consist of items drawn at random from the test bank. Because we are on an expedited semester schedule, I have adjusted the schedule for the class. All units will be open from Wednesday 10/18 until Tuesday 12/5. You may work on the units at your own pace as but all assignments are due at 11:59PM on 12/5.

Frequent and regular activity in this class will be essential for successful completion.
