# COURSE DESCRIPTION

This course combines a general education about aging in America with information about senior adults as crime victims, criminals or prison inmates. This includes facts about elders and crime, the role of criminal justice and other professionals in addressing the issues and future directions for public policy related to crime and aging.

# COURSE OBJECTIVES

(1) To gain factual knowledge about aging, crime and victimization.

(2) To learn to analyze and critically evaluate ideas, arguments, and points of view related to crime victimization and offending of older persons.

#### WEEKLY GROUP DISCUSSIONS:

Students will discuss points of interest from the course material each week. In an effort to facilitate meaningful discussions, students will be required to submit (1) "**original posts**" and (2) "**replies**" to other students' original posts:

(1) **Original Posts:** Students will respond to 5 weekly discussions. These are designed to promote critical thinking about a number of issues related to elder abuse victimization (or elder offending). Discussions will be based on lecture, **text**, *and/or* any supplemental materials for that week (such as video clips). Each posting must be a meaningful contribution to the discussion. Original posts must be submitted before each Wednesday at 11:59 pm during the weeks that posts are due (see course calendar for details). Late original posts will be eligible for half credit and will only be accepted until the close of the week (Sundays).

(1) **Replies:** Given that discussions work best when students contribute to other posts, students are also required to respond to one other student's original post for each of the weekly discussions. Replies must be meaningful and must be submitted before each Sunday at 11:59pm. *Late replies will not be accepted*.

**Example of acceptable reply:** "You make a good point because it relates to the recent lecture about.....in which we learned ......"

Example of unacceptable reply: "I completely agree with you!"

It is very important to read all original posts and replies before posting so you do not repeat content. Do not attempt to stop a discussion, but rather move it forward. Be respectful of others who disagree with you. At mid-term, the groups will be changed so that you are interacting with several different students throughout the semester.

EXAMINATIONS Your examinations will cover any required reading, lecture notes, videos and online class discussions covered in this course. These examinations are non-cumulative and are open-book, open-note. They may include true-false, multiple choice, matching and fill-in-the-blank questions. These exams are timed (75 minutes) allowing 1 ½ minutes per question. To do well on exams, students should view all lectures and complete assigned reading before beginning each exam.

**GRADING** Your grade will not be curved nor bartered. It is recommended that you monitor your own progress. There will be only one extra-credit assignment available - a Practice Quiz (worth 10 points) at the beginning of the semester.

## MANDATORY REPORTING OF KNOWN OR SUSPECTED ABUSE OF OTHERS

Texas law\* says anyone who thinks a child, or person 65 years or older, or an adult with disabilities is being abused, neglected, or exploited must report it to the Department of Family and Protective Services. A person who reports abuse in good faith is immune from civil or criminal liability. DFPS keeps the name of the person making the report confidential. Anyone who does not report suspected abuse can be held liable for a misdemeanor or felony. Time frames for investigating reports are based on the severity of the allegations. Reporting suspected abuse makes it possible for a family to get help.
