Course Description:

This course in microeconomics is designed to introduce students with the intermediate level analysis of consumer behavior, and output and pricing strategies of firms under different market structures. At the end of the course students are expected to develop a deep understanding of some fundamental economic theories that have widespread applicability in various subfields.

Prerequisite:

ECON 2300 or 2302

Course Objectives:

Upon completion of this course, the student will be able to explain

- 1. How consumers use prices to make decisions regarding what they buy.
- 2. How producers use prices to make decisions regarding what they sell.
- 3. How markets work to determine prices.
- 4. What happens when markets don't work the way they're supposed to.

Textbook:

Microeconomics by Robert S. Pindyck and Daniel L. Rubinfeld, 8th edition, Prentice Hall. You will not need Access code or CD for this class. Other editions of the textbook are also acceptable. However, students will be responsible for identifying the differences with the 8th edition.

Teaching Approach:

Lecture videos, and other course materials including assignments and exams will be available on Blackboard. Tabs to access Syllabus and Schedule, Virtual Office, Lecture Materials, Assignments, and Exams are available on the left panel on the Blackboard page for this course. You are expected to (i) view all lecture videos according to the schedule, (ii) carefully study the assigned reading materials, (iii) submit all assignments on time, (iv) contact the instructor for assistance when needed. Your learning and success in the course critically depends on regular study and solving the assignment question sets.

Assignments:

There will be 7 assignments (20 points each) based on the 9 broad topics that we will cover in this course. All assignments will have multiple choice questions. The total number of question in an assignment will vary depending on the topic(s) covered in that assignment. Assignment on every topic will be available on blackboard on the first day of topic discussion/lecture. Due dates and topics covered in each assignment are given in the course outline. Each assignment must be submitted before midnight of the respective due dates. You do not need to use ProctorFree for assignments. The assignments are meant to prepare you for the tests. Therefore, complete all assignments.

You can start solving the assignment questions anytime once it is available, save your work, and come back to it later to continue. You will have two attempts and your score from the best attempt will be counted. The correct answers for assignment questions will be available after the respective due dates. I will also post pdf versions of assignments (questions only) to help you study for the assignment/exams. Submit your answers online only through blackboard and do not email me your answers for assignment questions.

Best 5 assignment scores will count toward the course grade. There will be NO MAKE-UP assignment for any reason.

Exams:

There will be 3 midterm exams (100 points each), and a comprehensive final exam (100 points). Exam dates and topics covered in each exam are given in the course outline. Each midterm will have 25 multiple choice questions that you must complete within an hour and 15 minutes. The comprehensive final exam will have 40 multiple choice questions that you must complete within 2 hours. Each exam must be submitted before midnight of the respective due dates. Once you start an exam, you must complete it within the given time without any interruption.

All exams are CLOSED BOOK. We will be using "ProctorFree" for all exams. Therefore, you will need a webcam and a microphone while taking exams. You cannot use textbook, notes, lecture notes or videos, cell phone, tablets, google, or any other help during the exam – just like a face-to-face exam. You cannot leave the room or have other people in the same room while taking the exam. The step-by-step "Instructions for ProctorFree" are available on the left panel on the Blackboard page for this course.

A "Practice Exam for ProctorFree" that will not be considered for course grade is posted on Blackboard. Take the practice exam as soon as possible and well in advance to Exam 1 to check your system compatibility, webcam, and to make sure you know how to use ProctorFree. In case of any technical difficulty, contact the Blackboard support team immediately and solve all issues. YOU WILL NOT BE PERMITTED TO TAKE ANY OTHER EXAM WITHOUT TAKING THE PRACTICE EXAM FOR PROCTOR FREE FIRST. Therefore, make sure to take the practice test well before Exam 1.

Best 3 exam scores (among 3 midterms and a final exam) will count towards the course grade. That means, I will drop the lowest exam score among the 4 exams that you will take in total during the course. There will be NO MAKE-UP exam for any reason.

Extra Credit:

20% of the lowest 2 assignment scores will be added to your total as extra credit points. Additionally, 2 points will be given as extra credit to everyone if at least 65% students complete teaching evaluations before the deadline (This will still guarantee anonymity of the evaluation since I will not be able to know who completes the evaluation. All I will know is the percentage of students who complete the evaluation).
